### ANNUAL GENERAL MEETING SECOND SESSION

31 October 2002

#### Arrangements for the Elections to the Staff Union Committee

1. The schedule for the 2002 Staff Union election was adopted at the Annual General Meeting held on 30 October 2001. The election process is currently underway and the results will be announced on 22 November 2002.
2. The Annual General Meeting is accordingly invited to approve the calendar for the elections for 2003 and take such other steps as may be necessary to ensure the smooth operation of the elections, in particular the appointment of Returning Officers and the Electoral Commission.
3. The proposed calendar, for approval by the Annual General Meeting, is therefore as follows:

Monday, 15 September 2003:	distribution of the notice of election, the form for nominations and the form for the electoral statement at Geneva.
Monday, 29 September 2003:	deadline for the receipt of candidatures (with the electoral statement).
Wednesday, 1 October 2003:	publication of the list of candidates for election to the Staff Union Committee.
Friday, 3 October 2003:	despatch of electoral statements and ballot papers to Union members stationed outside Geneva.
Monday, 3 November 2003:	distribution of electoral statements and ballot papers at Geneva.
Thursday, 27 November 2003:	closing date of electoral period and counting of votes.
Friday, 28 November 2003:	publication of election results.
4. It is recalled that the elections for the renewal of Regional Members in the Staff Union Committee for the period 2002-2004 were being held from 13 May to 26 September 2002.
5. The list of candidates for the Staff Union Committee election currently underway is given in the Addendum to this document.

### Appointments of Returning Officers

6. The 2001 Annual General Meeting elected the following Union members as Returning Officers until 31 December 2002:

Ms. C. Rodríguez-Burgess (Chief Returning Officer)  
Ms. H. Bennett  
Mr. G. Bezou

7. The Annual General Meeting has now to appoint three Returning Officers for the period of 1 January to 31 December 2003. Staff Union members wishing to be candidates for the office of Returning Officer, are invited to submit their candidatures before the Annual General Meeting, i.e. by 4 p.m. on Wednesday, 30 October 2002, at the latest. The returning officers are not eligible to be candidate for the Staff Union Committee elections nor any other Union election.

8. It is proposed that, if the number of candidates exceeds the number of posts, elections should take place, as has been the practice in the past, by secret ballot. The three candidates having received the most votes will be declared Returning Officers for the period in question, the candidate with the highest number of ballots being designated Chief Returning Officer. Runners-up in the election will constitute a roster of substitutes to be called on in the event of needing to fill a vacancy.

### Appointment of the Electoral Commission

9. The 2001 Annual General Meeting elected the following Union members to the Electoral Commission until 31 December 2002.

10. The Annual General Meeting has now to appoint the members of the Electoral Commission for the period of 1 January to 31 December 2003. Staff Union members who wish to be candidates for the Electoral Commission are invited to submit their candidatures before the Annual General Meeting, i.e. by 4 p.m. on Wednesday, 30 October 2002 at the latest.

11. It is proposed that, if the number of candidates exceeds the number of posts, elections should take place, as has been the practice in the past, by secret ballot. The five candidates receiving the highest number of votes will be declared elected as titular members, the following five as substitute members.
