## Votes in Plenary

Given that votes will be held in Plenary today, starting at **1000**, it is essential for delegates with the right to vote to be present in the Assembly Hall **before 1000** in order to cast their vote when called upon to do so, and to ensure that the quorum is attained.

## Governing Body of the ILO

The 290th Session of the Governing Body will be held **tomorrow, Friday 18 June, at 1000** in the ILO building. If the Conference completes its work this morning, the groups of the Governing Body will meet **as shown below**. If the Conference plenary has to continue this afternoon, then the new group meetings will be announced during that sitting.

**N.B.** The following Government members of the Governing Body should submit their credentials **before 1200 today, Thursday 17 June**, to office A-241: Bahamas, Belgium, Canada, Ecuador, Islamic Republic of Iran, Italy, Republic of Korea, Luxembourg, Mexico, Niger, Nigeria, Pakistan, Romania, Slovenia, South Africa, Uruguay.

Any member State wishing to attend the Governing Body as an observer should also submit credentials to office A-241 **before 1200 today**.



## *Right to vote*

Delegates are reminded that votes are accepted only from accredited delegates who have registered for the Conference or from advisors who have been registered as their permanent substitutes or whom the delegates have appointed as their substitutes by notice in writing. Votes are not accepted where a delegate does not have the right to vote on account of the non-payment of contributions or incomplete delegations.

Where advisors are temporarily appointed as substitutes, forms for this purpose must be handed in to the **secretariat of the Credentials Committee (office A-261, near Door 15)** as soon as possible before any sitting at which a vote may be held (**today, before 09.30**). Substitutes whose names have not been communicated in time to the secretariat of the Credentials Committee will not be recognized at that sitting as having the right to vote in the place of the delegates concerned.

A standard form to enable delegates to notify their departure and the name of the person appointed to act in their stead is distributed in the Conference Hall and is also available at the Information Desk and from the office of the secretariat of the Credentials Committee (A-261). **Any delegate finally leaving Geneva and not appointing an advisor to act in his or her stead should also inform the secretariat of the Credentials Committee (A-261) in writing.**

### ***Voting procedure for ministers***

Ministers, heads of delegation, accredited in their capacity as ministers attending the Conference, and wishing to take part in votes held at the end of the Conference, must ensure that their Government delegates are present with them at the time of voting. They may also take on the status of Government delegate in order to vote in person. In the latter case, they are requested to contact office no. A-261 in order to make the necessary changes.
