1. Background and Justification

Timor-Leste as one of the youngest nations of the world has been actively engaged in combating Child Labour and fostering primary universal education not only in the capital city, Dili, but also in the rural areas. The V Government Programme is committed to focusing its attention on implementing activities and measures to eradicate practices that violate the rights of children, such as early marriages, child labour, and other types of exploitation, including domestic violence, sexual abuse.

The Government itself, through SEPFOPE, and its related entities, particularly Labour Inspection (IGT) has the primary responsibility to ensure that children are not engaged in illegal labour and that young workers of legal working age are duly protected and working in safe conditions. Ministry of Social Solidarity has responsibility to develop social policies and programmes to support families and vulnerable groups; and the Ministry of Education focus in attention on implementing the Education Framework law, which grants free and universal primary education to all boys and girls in Timor-Leste.

Beyond international conventions already ratified and the national legislation in place protecting child's rights, through ILO /IPEC Timor-Leste's Programme to Eliminate the Worst Forms of Child Labour, the country has made significant progress in the establishment of National Commissions against Child Labour (CNTI). CNTI aims to implement and monitor the ILO Convention No. 182 concerning the Elimination of the Worst Forms of Child Labour, and is also engaged in formally endorse the Hazardous List of Work to be prohibited for children, as well as to promote the development of an Action Plan to combat and irradiate child labour

2. Proposal, Objective, Outputs and Activities:

2.1 Proposal

The **World Day against Child Labour** is a great opportunity for SEPFOPE, in coordination with employers and workers representatives, IGT and CNTI, to organize a public, and media event in order to raise the public awareness on child labour of all stakeholders. The activities will be held in the capital city, Dili and will involve actively local communities and stakeholders, as well as several primary schools.

The event will be organized in Largo Lecidere, where thematic and assorted information on child labour will be discussed. Booklet containing information on children's rights, as well as desegregated data on child labour will be released. CNTI will also formally inform the public on its main roles and functions and engage in ILO campaign "Hold up you red card to child labour" so several red cards will be distributed and used during the event. Additionally, as part of the campaign, the CNTI will also request public figures in Timor-Leste to take a photo to using the red card.

Members of the Government, National Parliament, Presidency of Republic, and other public entities, as well as trade unions, employers' representatives, and civil society are invited to actively participate in the activities further described and to get their red card against child labour.

The theme of the activity is "Say no to Child Labour In Timor-Leste" or in Tetun "Lae ba trabalho infantil iha Timor-Leste"

2.2 Objectives

The main objectives of the celebrations are:

- a) Use the Red Card campaign to raise public awareness of the role that children play in the society and the importance of attending school, as vehicle to combat child labour, particularly focusing on the importance of social protection;
- b) Discuss with participants social measures and activities to be implemented in Timor-Leste to eradicate practices of child labour, taking into account the situations of most vulnerable children, especially child living in isolated and rural areas;
- c) Brief participants and the main stakeholders about the legal framework in place in Timor-Leste for protecting young persons who can legally work under the Labour Code, upon compliance with rules of safety, health and respect for physical, mental and moral
- d) Brief the participants and the main local stakeholders about the CNTI's roles and responsibilities in combating child labour.

2.3 Outputs

- a) Increase the knowledge and public awareness of the main problems associate to child labour, and spread the Red Card campaign to the main rural stakeholders;
- b) Define key and priority social measures and activities to be implemented in Timor-Leste and specific actions to targeting vulnerable children, especially children living in isolated and
- c) Participants and main stakeholders informed about the legal framework in place in Timor-Leste for protecting young person who can legally work under the law.
- d) Participants and the main local stakeholders informed about the CNTI's roles and responsibilities.

2.4 Activities

a) Formal speech by the main government agencies represented in the event, such as the Secretary of State for Vocational Training and Employment Policy and the Ministry of Social Solidarity;

- b) Presentation of the CNTI's responsibilities and the planned activities for 2014 in combating child labour and its commitment to the Red Card campaign;
- c) Distribution of a booklet containing information on children's rights and child labour;
- d) Distribution of package containing (candies, t-shirts with red car printed, school material, such as pen and notebooks) to the children;
- e) Interaction, discussions and awareness-raising among participants;
