



## Information Note Seminar on Promoting Decent Work for Homeworkers 16-17 December 2015, DKI Jakarta

#### 1. Background

The ILO MAMPU Project is part of the Empowering Indonesian Women for Poverty Reduction Programme (Maju Perempuan Indonesia untuk Penanggulangan Kemiskinan – MAMPU), funded by the Government of Australia's Department of Foreign Affairs and Trade (DFAT). The ILO MAMPU Project aims to improve access to employment and decent work for women homeworkers and women workers with disabilities in the conditions of equality in Indonesia.

The Project Phase II started in February 2014 and worked closely with the Ministry of Manpower, Employers' and Trade Union organizations and selected civil society organizations. Community-based action programmes to provide direct support to homeworkers were implemented by selected civil society organizations (CSOs), namely, Yayasan BITRA Indonesia (Bitra), Yayasan Annisa Swasti (Yasanti), Trade Unions Rights Centre (TURC), Mitra Wanita Pekerja Rumahan Indonesia (MWPRI), to improve the working conditions of homeworkers in North Sumatra, Banten, West Java, Central Java, Yogyakarta, and East Java. Trade union partners (FSB Kamiparho (KSBSI), FSB Garteks (KSBSI), FSP RTMM (KSPSI Rekonsiliasi), FSP TSK (KSPSI Rekonsiliasi), FSP TSK (KSPSI Rekonsiliasi), FSP TSK (KSPSI Rekonsiliasi) and KSPI) also worked to increase their awareness on homeworkers' issues to start extending trade union support to homeworkers.

The key officials of the Ministry of Manpower, the Ministry of National Development Planning at the central and provincial levels as well as APNDO members increased awareness on homeworkers' issues. The lessons from the field by CSOs and Trade Union partners were shared during policy dialogue and knowledge sharing events to advocate for the recognition and protection of homeworkers as workers. The Project also carried out a number of research to better understand the working conditions and employment characteristics of homeworkers so that the information from the research can be used for policy advocacy and to contribute to the development of appropriate programmes.

After almost two years of implementation, the Project generated rich experiences and data which should be shared with the relevant stakeholders and wider audience to increase their knowledge and work towards improving the living and working conditions of homeworkers. Therefore, the Project in collaboration with the Ministry of Manpower is planning a Seminar on Promoting Decent Work for Homeworkers to disseminate the findings from research and good practices from community-based programmes.





#### 2. Objectives

The objectives of the seminar are as follows:

- 1. To increase understanding on homeworkers' issues in Indonesia among the relevant stakeholders and the general public through presentation of the research findings and sharing of experiences from the project partners.
- 2. To raise awareness on the significance of homeworkers' issues and advocate for the development policies/programmes/practices to promote decent work for homeworkers in Indonesia.
- 3. To equip the relevant stakeholders with knowledge on good practices and lessons on organizing home-based workers.

The seminar will be structured to achieve the objectives and there will a session to share international perspective on home work as well as the situation of homeworkers in Indonesia, a session to share the practices of employers and an international buyer in engaging homeworkers and promoting better labour standards compliance, and a session to learn effective strategies and practices in promoting decent work for homeworkers. The workshop will also introduce useful tools and guidelines for promoting decent work for homeworkers. The Project will work with the workers' and employers' organizations in sharing knowledge and developing strategic plans to move forward on homeworkers' issues on day 2.

The list of research and documentation to be shared during the seminar includes:

- Mapping of homeworkers in North Sumatra, Banten, West Java, Central Java, Yogyakarta, and East Java
- Results of consultations on challenges and aspirations for decent work for women with disabilities
- Employers' practices on engaging homeworkers
- Working conditions and relations of homeworkers engaged in the IKEA's rattan industry value chain
- Report on organizing and home-based workers and promoting decent work for home-based workers: experiences from Chile, India, the Philippines, and Thailand
- Documentation of good practices in organizing and promoting decent work for homeworkers in Indonesia
- Training manual on developing community-based childcare facilities
- Good practice guidelines for the employment of homeworkers
- APINDO IEC materials on TB for workers.
