




#### A look to our past: the Tboli indigenous farming system



Against the backdrop of the global financial crisis and rising food, fuel and commodity prices, addressing poverty and inequality in the Philippines



The report is methodological research for compiling purchasing power parities (PPP) for measuring poverty in the



region. The study covers 16 out of 23 economies participating in the 2005 International Comparison Program in Asia and the Pacific. It presents a detailed account of the activities undertaken to estimates PPPs using the recommended methodology of the Poverty Advisory Group of the World Bank, as well as alternative PPPs derived from poverty-specific price surveys.
