



### Preparatory tripartite MLC, 2006, Committee: background paper

The purpose of this meeting of the Preparatory Committee is to: (a) *exchange information* regarding steps that Members have taken to implement the MLC, 2006 if they have ratified or are moving towards ratification; (b) *identify any common issues* (particularly any difficulties regarding interpretation and application to particular encountered during preparations for ratification and implementation of the LMC, 2006); (c) *identify matters* that will require urgent action by the Special Tripartite Committee, once it has been established, and *provide advice* on any preparatory work or other steps to be taken to enable it to begin functioning.
