

Training Resource Pack on the Elimination of Hazardous Child Labour in Agriculture



What is the Training Resource Pack?

A training resource pack providing information to eliminate hazardous child labour in agriculture, in use since the mid-2000s and updated in 2009

For whom?

- **Direct beneficiaries:**
 - Farmer trainers
 - Employers' federations
 - Trade unions
 - Local government officers
 - All actors involved in tackling hazardous child labour locally
- **Ultimate beneficiaries:** Children working in agriculture

For what purpose?

- Train farmer trainers and other actors involved in agriculture so they can run training courses for their communities on hazardous child labour
- Help farmer trainers plan and run awareness-raising and training activities with farmers and their communities
- Provide farmer trainers with information on the elimination of the worst forms of child labour, particularly hazardous child labour
- Help improve Occupational Safety and Health on farms and promote implementation of the ILO Convention Concerning the Prohibition and Immediate Action for Elimination of the Worst Forms of Child Labour, 1999 (No. 182), and its accompanying Recommendation (No. 190)
- Help farmer trainers and other actors involved in agriculture learn how to carry out and implement health and safety risk assessments/controls as a basis for improving health and safety standards, and eliminating hazardous child labour on farms and in their villages communities

How is it delivered?

- Training of trainers
- Training of beneficiaries

What are its components?

Three books:

- A training of trainer's guide
 - Training course activities for farmers containing exercises for farmers
 - Additional resources for trainers
- A CD-rom with the materials

Which technical areas are covered?

- Child labour
- Worst forms of child labour
- Hazardous child labour
- Occupational safety and health

Can it cover more technical areas?

Yes, the Training Resource Pack has been adapted to be used in other packs on child labour and cooperatives [with ILO's Cooperative Unit and the International Cooperative Alliance (ICA)], child labour and fishing (with FAO), child labour and worker representatives (with ILO's Bureau for Workers' Activities), child labour and labour inspection



Where has it been used?

In at least 25 countries: Albania, Azerbaijan, Bosnia, Bulgaria, Cambodia, Cameroun, Ghana, Ivory Coast, Kazakhstan, Kenya, Kosovo, Kyrgyzstan, Malawi, Mali, Moldova, Nigeria, Romania, Senegal, South Africa, Tajikistan, Tanzania, Turkey, Uganda, Ukraine, and Zambia (see map)

Which languages?

Available in 5 languages: English, French, Portuguese, Romanian, and Spanish

Is it suitable for rural areas?

Yes, it focuses on child labour in agriculture

What are its strengths?

- Easy to use
- Participatory
- Easy to translate
- Training course activities for farmers to be printed locally
- Complements the IPEC tool *Tackling hazardous child labour: guidance on policy and practice*
- Has been used by FAO and by the other members of the International Partnership for Cooperation on Child Labour in Agriculture (IPCCLA)
