Decide

Article 1

The base daily wage of 8,000 (eight thousand) Riels shall be adjusted to 40,000 (forty thousand) Riels.

Article 2

This new adjusted base daily wage is the rate for calculation of fine imposed in compliance with the penalty in Chapter 16 of the Labour Law.

Article 3

Secretary General, Cabinet Chief, Director General, General Inspector, Directors of Departments, and Head of relevant units under the Ministry of Justice and Ministry of Labour and Vocational Training shall be in charge of implementing this Prakas in a highly effective manner from the date of signature herein.
