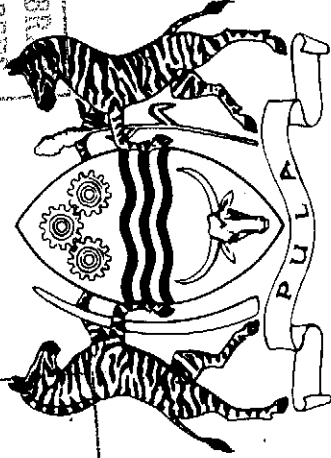

ARRANGEMENT OF PARAGRAPHS

PARAGRAPH

1. Citation
2. Commencement of Act No. 32 of 2004

IN EXERCISE of the powers conferred on the Minister of Trade and Industry by section 1 of the Companies Act, 2003, the following Order is hereby made —
Citation

1. This Order may be cited as the Companies Act (Date of Commencement) Order, 2007.
2. The 3rd of July, 2007, is hereby appointed as the date on which the Companies Act, 2003, shall come into force.
