2. MINIMUM WAGES

(1) With effect from 1 July 2013 an employer must pay an employee, at least the minimum wage prescribed in this clause.

Replace table 1 in clause 2 (2) as reflected in the Government Gazette No. 35462 of June 2012 with the following table:

Substitute clause 9 (1) (a) as reflected in the Government Gazette No. 35462 of June 2012 with the following:

9. BOARDING ALLOWANCES

(1) If an employer requires an employee to sleep over at a place other than where the employee resides, the employer must either-

- (a) Pay the employee the amount as reflected in table 2 below per night; or
- (b) Reimburse the employee's reasonable expenses; or
- (c) With the agreement of the employee, accommodate the employee in reasonable accommodation
