

NON-CITIZENS (WORK PERMITS) (FEES) REGULATIONS 1982

1. These regulations may be cited as the Non-Citizens (Work Permits) (Fees) Regulations 1982.
 2. There shall be paid the fee set out in the Schedule for –
 - (a) the issue of a work permit to a non-citizen;
 - (b) where a work permit is issued for a specific period, for the renewal of the work permit.
 3. (1) Where a work permit is lost or damaged, the holder may apply to the Minister for the issue of a duplicate work permit.
(2) A fee of Rs 500 shall be paid for the issue of a duplicate work permit.
 4. Notwithstanding regulations 2 and 3, no fee shall be payable in respect of the issue or renewal of a work permit or the issue of a duplicate in respect of any person engaged in a religious or a charitable institution approved by the Minister.
 5. The Minister may exempt any non-citizen from payment of any fee payable in respect of the issue or renewal of a work permit or the issue of a duplicate.
 6. These regulations shall not extend to any application which has been approved by the Minister before the commencement of these regulations.
 7. The Non-Citizens Work Permits (Fees) Regulations 1977 are revoked.
