**Thailand Minimum Wage Rates increased for 2008**

Mr. Jutathawat Intharasisuk, the Permanent Secretary of Labour Minister of Thailand, disclosed on May 16, 2008 that the Ministerial Regulation of Minimum Wage Rate (No. 9) dated on May 2, 2008 and proposed by the Ministry of Labour was acknowledged and approved by the Cabinet. The regulation will come into force on June 1, 2008.
