**THE MINIMUM WAGE ACT**

**THE NATIONAL MINIMUM WAGE (AMENDMENT) ORDER, 2011**

In exercise of the powers conferred upon the Minister by section 3 of the Minimum Wage Act. and of every other power hereunto enabling, the following Order is hereby made:—

1. This Order may be cited as the National Minimum Wage (Amendment) Order, 2011. and shall be read and construed as one with the National Minimum Wage Order, 1975 (hereinafter referred to as the principal Order) and all amendments thereto, and shall come into operation on the 28th day of February, 2011.

2. Paragraph 4 of the principal Order is amended—

- (a) by deleting the words "11th day of May, 2009" and substituting therefor the words "28th day of February, 2011";
- (b) in sub-paragraph (a) by deleting the numerals "SI01.75" and substituting therefor the numerals "\$ 112.50";

- (c) in sub-paragraph (b) by deleting the numerals "\$152.62" and substituting therefor the numerals "\$ 168.75"; and
- (d) in sub-paragraph (c) by deleting the numerals "\$203.50" and substituting therefor the numerals "\$225.00".

3. Paragraph 5 of the principal Order is amended—

- (a) in sub-paragraph (1) by deleting the words " 11 th day of May, 2009" and substituting therefor the words "28th day of February, 2011";
- (b) in sub-paragraph (1)(a), by deleting the numerals "\$4,070.00" and "\$152.62" substituting therefor the numerals "\$4,500.00" and "\$ 168.75" respectively;
- (c) in sub-paragraph (1)(b) by deleting the numerals "\$4,171.75." and "\$152.62" and substituting therefor the numerals "\$4,612.50" and "\$168.75" respectively;
- (d) in sub-paragraph (1)(c) by deleting the numerals "\$4,273.50" and "\$ 152.62" and substituting therefor the numerals "\$4,725.00" and "\$ 168.75" respectively;
- (e) in sub-paragraph (1)(d) by deleting the numerals "\$4,375.25" and "\$ 152.62" and substituting therefor the numerals "\$4,837.50" and "\$168.75" respectively;
- (f) in sub-paragraph (1)(e) by deleting the numerals "\$4,477.00" and "\$ 152.62" and substituting therefor the numerals "\$4,950.00" and "\$ 168.75" respectively;
- (g) in sub-paragraph (1)(f) by deleting the numerals "\$203.50" and substituting therefor the numerals "\$225.00"
- (h) in sub-paragraph (2) by deleting the words "\$ 11 th day of May, 2009" and substituting therefor the words "28th day of February, 2011";
- (i) in sub-paragraph (2)(a) by deleting the numerals "\$101.75" and substituting therefor the numerals "\$112.50";
- (j) in sub-paragraph (2)(b) by deleting the numerals "\$ 152.62" and substituting therefor the numerals "\$168.75"; and
- (k) in sub-paragraph (2)(c) by deleting the numerals "\$203.50" and substituting therefor the numerals "\$225.00".

**Tin:- MINIMUM WAGE (INDUSTRIAL SECURITY GUARDS) (AMENDMENT)**  
**ORDI:R, 2011**

In exercise of the powers conferred upon the Minister by section 3 of the Minimum Wage Act, and of every other power hereunto enabling, the following Order is hereby made:—

1. This Order may be cited as the Minimum Wage (Industrial Security Guards) (Amendment) Order, 2011 and shall be read and construed as one with the Minimum Wage (Industrial Security Guards) Order, 1982 (hereinafter referred to as the principal Order) and all amendments thereto, and shall come into operation on the 28th day of February, 2011.

2. Paragraph 4 of the principal Order is amended—

- (a) by deleting the words "1st day of June, 2009" and substituting therefor the words "28th day of February, 2011";

- (b) in sub-paragraph (a), by deleting the numerals "\$151.25" and substituting therefor the numerals "\$ 166.38";
- (c) in sub-paragraph (b) by deleting the numerals "\$226.87" and substituting therefor the numerals "\$249.57"; and
- (d) in sub-paragraph (c) by deleting the numerals "\$302.50" and substituting therefor the numerals "\$332.76".

3. Paragraph 6 of the principal Order is amended—

- (a) by deleting the words "(1) With effect from the 1st day of June, 2009, and subject to the provisions of sub-paragraph (2)" and substituting therefor the words "With effect from the 28th day of February, 2011";
- (b) in sub-paragraph (a), as renumbered, by deleting the numerals "\$27.50" and substituting therefor the numerals "\$30.25";
- (c) in sub-paragraph (b), as renumbered, by deleting the numerals "\$30.25" and substituting therefor the numerals "\$33.28";
- (d) in sub-paragraph (c), as renumbered, by deleting the numerals "\$20.35" and substituting therefor the numerals "\$22.39";
- (e) by deleting sub-paragraph (2).

4. Paragraph 8 (a) of the principal Order is amended by deleting the words "one million five hundred thousand" and substituting therefor the words "two million".
