Trends in ILO approvals in 2021

The COVID-19 pandemic's impact on the world of work emphasizes the continued relevance of the ILO's approach to promoting a human centred recovery. The past year has also illustrated the strength of the ILO's partnerships as funding partners continued to contribute to the ILO's work despite the negative impact of the pandemic on their economies. New approvals¹ of voluntary non-core funding in 2021 reached US\$319.0 million, a decrease of 11 per cent from 2020, but the fourth highest contribution total in the past ten years. In addition, the ILO received US\$ 16.0 million in [Regular Budget Supplementary Account \(RBSA\) funds](#), or voluntary core funding in 2021, which comes from² Denmark, Belgium, the Netherlands, Sweden, Luxembourg, Germany, France, Italy and Norway.

Twenty funding partners accounted for 95 per cent of voluntary contributions, with the United Nations (UN), the European

Commission and the United States registering as the largest three contributors, respectively. Indeed, the ILO's reinforced position within a reformed UN, has led to increases in contributions from multiple UN funds, including the MPTF COVID-19 Response and Recovery Fund, the Joint SDG Fund, and Peacebuilding Fund as well as significant increases in contributions from UNICEF and IFAD. Overall, social protection and working to end child labour and forced labour were among the most funded areas of work in 2021.

Looking beyond the ILO, the total amount of [Official Development Assistance \(ODA\) increased in 2021](#) by .6%. This slight increase was mainly directed towards humanitarian assistance and health related activities. The global needs for ODA for development purposes increased significantly and, hence, the global competition for such funds has remained strong if not increased. It is in this context that the continued commitment of the ILO's funding partners needs to be appreciated. Their support has been essential for the ILO's human-centred recovery responses from the COVID-19 pandemic in many of its member States.

The ILO's human centred approach to recovery also requires the support of development and funding partners in the years to come. In particular, themes such as decent jobs and inclusive economic growth, social protection, protecting workers and sustaining enterprises, due diligence and supply chains, the humanitarian-development nexus, a just transition towards a carbon-neutral global economy and gender equality may have increased attention from funding partners.

The Office will continue to promote three funding modalities as reflected in the ILO Development Cooperation Strategy 2020-25 and in line with the UN Funding Compact: non-earmarked contributions;

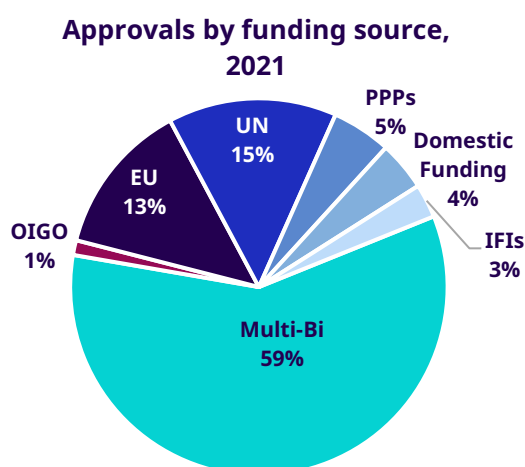

lightly earmarked and pooled funding; and earmarked funding. The Office will continue its efforts to define its needs for additional partnerships and voluntary funding including through the use of structured funding dialogues³.

Approvals highlights in 2021

- The commitment of funding partners to supporting the ILO's response to the COVID-19 pandemic continued to be a defining feature of 2021. New activities directly related to the response included supporting social protection and ending child labour as well as promoting employment intensive investment, skills development and enterprise development.
- Average annual approvals have steadily increased since 2010. Total approvals for the period 2010-2013, on average, totalled US\$238.0 million per year. For the period 2018-21, average annual approvals reached US\$ 362.3 million thanks to record-setting years in 2017 and 2019.
- Accounting for 59 per cent of total approvals in 2021, multi-bilateral development partners remained



the largest source of voluntary funding. This was followed by the United Nations (15%), the European Commission (13%) which channels EU member states contributions from the EC's budget. Aligning with trends observed in previous years, PPPs (5%) and Domestic Development Funding (4%) round out the top five sources of funding for 2021 approvals.

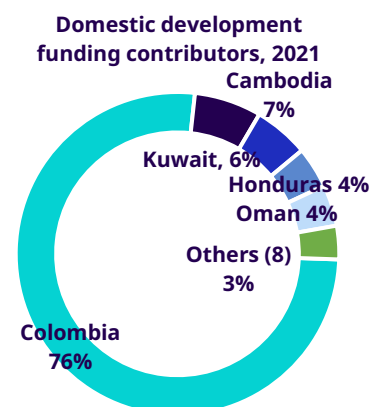
- For multi-bilateral approvals in 2021: 19.5% came from the United States, 11.6% from Switzerland, 8.6% from Japan, 8.2% from Norway and 7.8% from the Netherlands. Key areas funded include the fight against child labour and forced labour as well as social protection and employment promotion, especially employment-intensive investments and skills development
- Approvals from the UN system accounted for the largest source of approvals in 2021, reaching US\$ 46.2 million – nearly US\$ 15 million above the average recorded over the past four years. The UN portfolio is marked by an increasing number of inter-agency contributions as well as Joint Programmes funded by Multi Partner Trust Funds (MPTFs). Activities are weighted toward supporting COVID-19 response initiatives and social protection. These include several global programmes that have a thematic focus on social protection, employment promotion, enterprise promotion, skills development and work quality issues. These approvals have included contributions from UNAIDS for the HIV/AIDS at the workplace programme, and other large inter-agency funded partnerships with several UN entities, such as with UNICEF, IFAD and IOM.
- The European Commission continued to be the largest individual contributor to the ILO's approvals in 2021.⁴ Its new approvals included a focus on the promotion of social protection and enterprise development in favour of decent job creation, with particularly important contributions to the ILO's work in Iraq and Sierra Leone.
- Approvals from non-OECD/DAC countries⁵ in 2021 were roughly aligned with figures observed in 2020, with approvals of US\$ 1.1 million from Brazil, US\$ 1 million from China and US\$ 327,000 from Panama.
- Public Private Partnership approvals totalled US\$16.3 million in 2021, which aligns with the average observed in the past four years. This included important private sector contributions for areas of work including ending child labour and supporting compliance with international labour laws in textile supply chains through the Better Work Programme.

- Domestic Development Funding refers to funding by the government of a member State for ILO work in the country. As in 2020, this funding source, accounts for more than US\$13.5 million of approvals, or about four per cent of total funding in 2021. This was thanks largely to contributions from Colombia, Cambodia, Kuwait, Honduras and Oman. This funding focused on supporting employment intensive investment and skills training as well as technical capacity building in fields ranging from social protection to improving the application of labour standards. Contributions from an additional eight countries⁶ were directed primarily to social protection as well as occupation safety and health (OSH).
- Approvals in 2021 included a focus on social protection (14.9% of approvals) and ending child labour (11.7%), which, alongside employment intensive investment (11.0%), skills development (9.0%) and enterprise development (7.7%) rounded out the top five areas of work. In the face of continued strong interest as part of COVID-19 response, funding contributions for social protection activities remained around 25% above average.
- In 2021, 28.6% of total approvals were for Africa and 18.7% for Asia, followed by the Arab States (9.2%), the Americas (9.3%), and Europe (3.2%). In line with the increase in larger, multi-regional programmes observed in recent years, a significant percentage of approvals were also for interregional or global projects (32.7%). While figures for Africa and the Americas were higher than the average for 2018-21, approvals for the Arab States, Asia and Global initiatives declined slightly. Europe experienced a large drop in contributions in 2021 but remains aligned with historical contribution levels (2010-13) to the region. It should be noted that approvals for Europe were at a record high in 2020.
 - Of the total of new approvals in 2021, 35.8% were financially managed by headquarters and 64.2% by the field. This distribution represents a 2.3 percentage point increase for the field compared to 2020.



For new approvals in 2021:

- In the Africa region, activities are mainly focused on employment intensive investment, employment promotion and skills development.
- In the Americas region, projects focus on ending child labour and forced labour and promoting skills development.
- In Europe and Central Asia, there is a strong focus on employment promotion and supporting efforts to end child labour.
- In Asia and the Pacific, activities are mainly focused on social protection, enterprise development and employment promotion.
- In the Arab States region, projects focus on promoting social protection and enterprise development.

The following tables provide more detailed information about total voluntary non-core funding approvals in 2021. Many of the tables also provide a comparative overview of approval data for the period 2018-2021. Information is presented by source of funds, partner category, technical field, geographical distribution, administrative responsibility, and a combination of all the above.
