Individual Cases: Cases included in the final list will be automatically registered and evenly distributed by the Office, on the basis of a rotating alphabetical system, following the French alphabetical order. This year, the registration will begin with countries with the letter “**N**”. The complexity of cases may also be taken into account to ensure more predictability and to allow a case to be discussed in the same session/day.

Cases will be divided in two groups: the first group of countries to be registered following the above alphabetical order will consist of those cases in which a double footnote was inserted by the Committee of Experts and are found in [paragraph 112](#) of the Committee’s report. The second group of countries will consist of all the other cases on the final list and they will be registered by the Office following the above-mentioned alphabetical order. The case numbers set in the provisional schedule below do not correspond to any particular countries until the final list is adopted.
