PROCEDURAL AND OTHER MATTERS

Information document 1: Internal work plan for the SRM TWG's initial programme of work (2024)

- This document sets out *the seventh internal work plan for the SRM TWG's initial programme of work*.
- The document records, for internal work planning purposes and to ensure a transparent and measurable process, the position of each instrument in the review process and decisions (including interim decisions) taken by the SRM TWG. The internal work plan is updated at each meeting of the SRM TWG.

9 August 2024

At its first meeting, the SRM TWG decided to review 235 international labour standards that it included in an initial programme of work. This information document is an internal work plan, updated after each meeting to show the status of each of those 235 international labour standards with regard to the work undertaken by the SRM TWG.

In the table below, international labour standards are shaded different colours to show their status. The review has been started for the eighty-four standards shaded **green**; the SRM TWG will continue to monitor or take further action as necessary in relation to those standards. The review of ninety-nine standards shaded **grey** is complete and there is no further action needed by the SRM TWG beyond monitoring; in many cases, the follow-up by the Organisation to the SRM TWG's review is also complete. The SRM TWG has not yet started its review of the fifty-two standards shaded **red**.

In summary, out of the 235 instruments included in the initial programme of work, the SRM TWG has taken action in relation to 182. This includes the following, non-exclusive, actions:

- Sixty-eight instruments were referred to the Special Tripartite Committee established under the Maritime Labour Convention, 2006 (STC MLC).¹
- Sixty-three instruments previously identified as outdated have been examined.² The follow-up undertaken in relation to these instruments is being considered by the SRM TWG in its reviews of instruments on the same sub-topics.
- Fifty-one instruments have been reviewed by the SRM TWG in its third, fourth, fifth, sixth, seventh and eighth meetings (2017-2023): twenty-four instruments on OSH, two instruments on labour inspection, two instruments on labour statistics, seven instruments on employment policy, six instruments on social security, three instruments on maternity protection and seven instruments on protection of children and young persons. Twenty-six instruments were classified as up to date; eleven instruments were requiring further action to ensure their continued and future relevance; and nine instruments were classified as outdated. At the eighth meeting, the decision on the classification of five instruments concerning night work of children and young persons was postponed, pending research requested from the Office, until its next review at an appropriate time.

- Fifty-two instruments have been abrogated, withdrawn, recommended for abrogation or withdrawal, or their juridical replacement has been noted at the recommendation of the SRM TWG. A further sixty-five instruments have been abrogated, withdrawn, recommended for abrogation or withdrawal, or their juridical replacement has been noted at the recommendation of the STC MLC.
- Twenty-nine instruments are in the process of being promoted at the recommendation of the SRM TWG. In some cases this involves a general ratification campaign, and in others the campaign is targeted to encourage countries with ratifications of outdated instruments to consider ratifying related more up-to-date Conventions or Protocols.
- Six gaps in coverage were identified by the SRM TWG, resulting in five proposals for standard-setting action.

At its ninth meeting in 2024, the SRM TWG is scheduled to review fourteen instruments.

The SRM TWG may wish to provide guidance to the Office in respect of follow-up action undertaken.
