- BRAZIL WAS ONE OF THE COUNTRIES THAT TRAFFICKED THE MOST PEOPLE FOR LABOUR EXPLOITATION.

BRIEF HISTORY

- THE RESULT IS A LEGACY OF SOCIAL INEQUALITY, EXCLUSION AND VIOLENCE.
- SUBSEQUENT TO THE ABOLITION OF SLAVERY, THESE INDIVIDUALS FACED DEPRIVATION OF ACCESS TO LAND, HEALTH, EDUCATION, AND INCOME. THEY ENDURED STIGMATIZATION, EXPLOITATION, AND VIOLATIONS OF THEIR RIGHTS.



Áurea law

On May 13, 1888, Princess Isabel signed the Áurea law, which abolished slavery in Brazil.



At the age of 523 years, Brazil's historical trajectory has been characterized by 350 years of slavery, succeeded by a relatively shorter period of just 110 years of democratic governance..

BRIEF HISTORY



- THE SOLUTIONS OFFERED TO THE CHALLENGES FACED BY MARGINALISED INDIVIDUALS IN SOCIETY EMANATED FROM BOTH CHURCHES AND NON-GOVERNMENTAL ORGANISATIONS.
- NEVERTHELESS, THIS ASSISTANCE WAS DIRECTED TOWARDS RELIGIOUS SALVATION, BENEVOLENCE, AS WELL AS MORAL AND BEHAVIORAL CONTROL OVER IMPOVERISHED INDIVIDUALS. THIS PHENOMENON IS COMMONLY REFERRED TO AS WELFARISM.
- THE STATE DID NOT ENDORSE THESE CHARITABLE ACTIONS AS THEY FAILED TO ENSURE THE PROVISION OF FUNDAMENTAL RIGHTS.

BRIEF HISTORY

- AFTER 21 YEARS OF MILITARY DICTATORSHIP, BRAZIL'S FEDERAL CONSTITUTION WAS PROMULGATED IN 1988.
- THIS DOCUMENT OUTLINES THE RIGHTS AND OBLIGATIONS OF OUR NATION'S CITIZENS AND POLITICAL ENTITIES. ORIGINATING AT THE END OF THE DICTATORSHIP AND DRAWN UP THROUGH A BROAD PUBLIC DISCOURSE, IT ACQUIRED THE NAME OF CITIZEN CONSTITUTION.

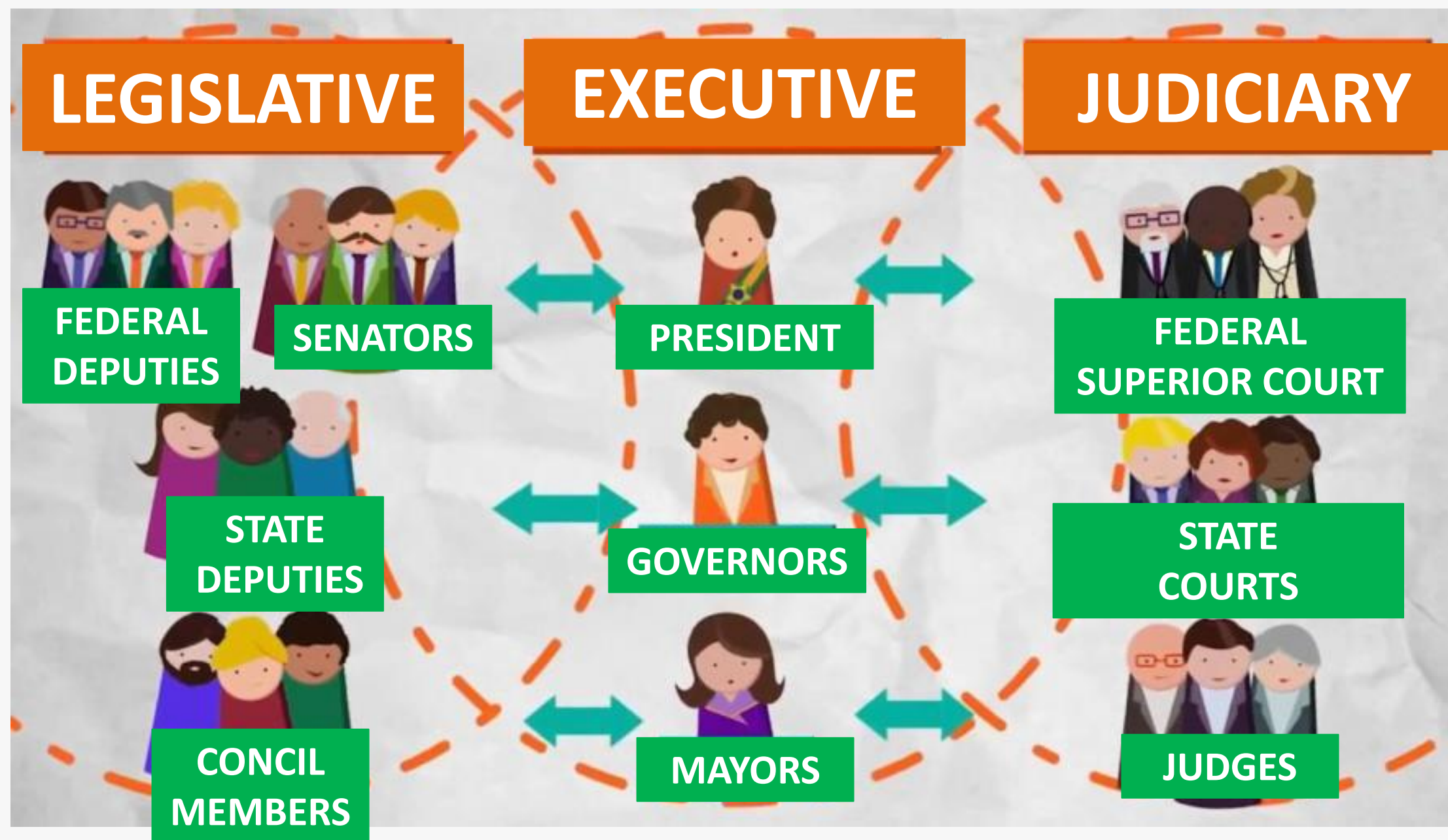

THE SEPARATION OF POWERS IN BRAZIL



This separation of powers aims to balance the system, preventing one branch of government from exercising absolute control and protecting citizens against possible abuses of power. Each power has different functions, responsibilities and limits but they share the responsibility of monitoring and imposing limits between themselves.

1. Legislative:

- To draft, discuss, and approve laws. The Legislative Branch is bicameral in Brazil, comprising the Chamber of Deputies and the Federal Senate. Legislators are elected by the people to represent their interests in the creation of laws.

2. Executive:

- Implement and execute laws. The President of the Republic is the head of the Executive Branch in Brazil. They are elected by direct vote and are responsible for administering the country, sanctioning or vetoing bills approved by the Legislature, and managing public policies.

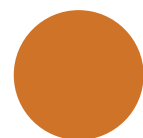
3. Judiciary:

- Interpret and apply laws. The Judiciary is composed of several courts and judges. They are responsible for resolving conflicts in the interpretation of the law, ensuring justice in civil and criminal cases, and ensuring that laws comply with the Constitution.

PUBLIC SOCIAL ASSISTANCE POLICY

- THE FEDERAL CONSTITUTION, IN ARTICLES 203 AND 204, ESTABLISHED SOCIAL ASSISTANCE AS A UNIVERSAL RIGHT FOR ANYONE IN NEED, WITHOUT THE REQUIREMENT OF A PRIOR CONTRIBUTION TO SOCIAL SECURITY.
- ACCORDING TO THE 1988 FEDERAL CONSTITUTION, ANY GOVERNMENT INITIATIVES IN THE REALM OF SOCIAL ASSISTANCE MUST BE FUNDED THROUGH RESOURCES ALLOCATED IN THE SOCIAL SECURITY BUDGET, AS STIPULATED IN ARTICLE 195, IN ADDITION TO OTHER SPECIFIED SOURCES DETAILED IN ARTICLE 204.

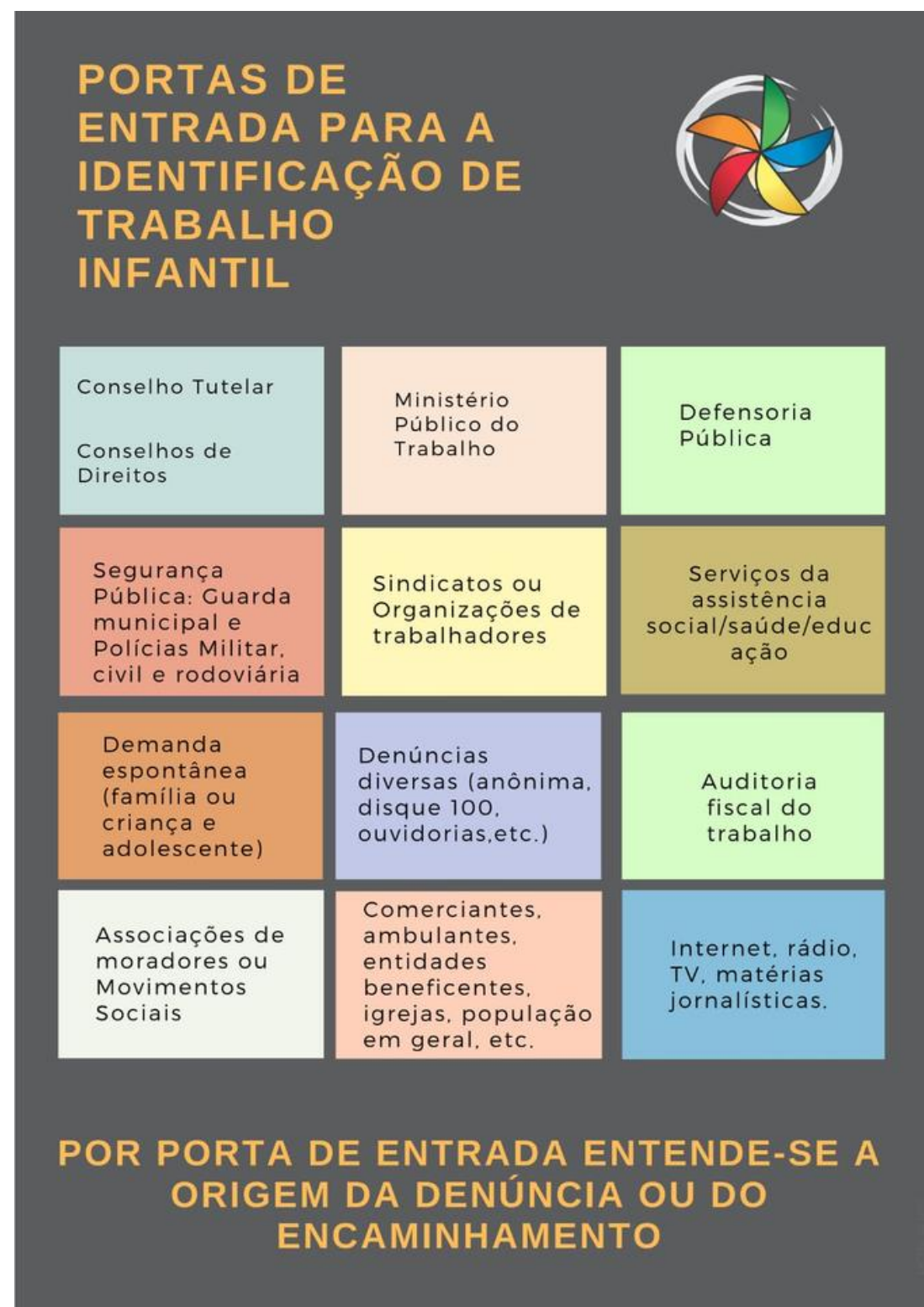

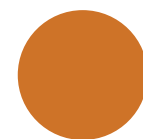

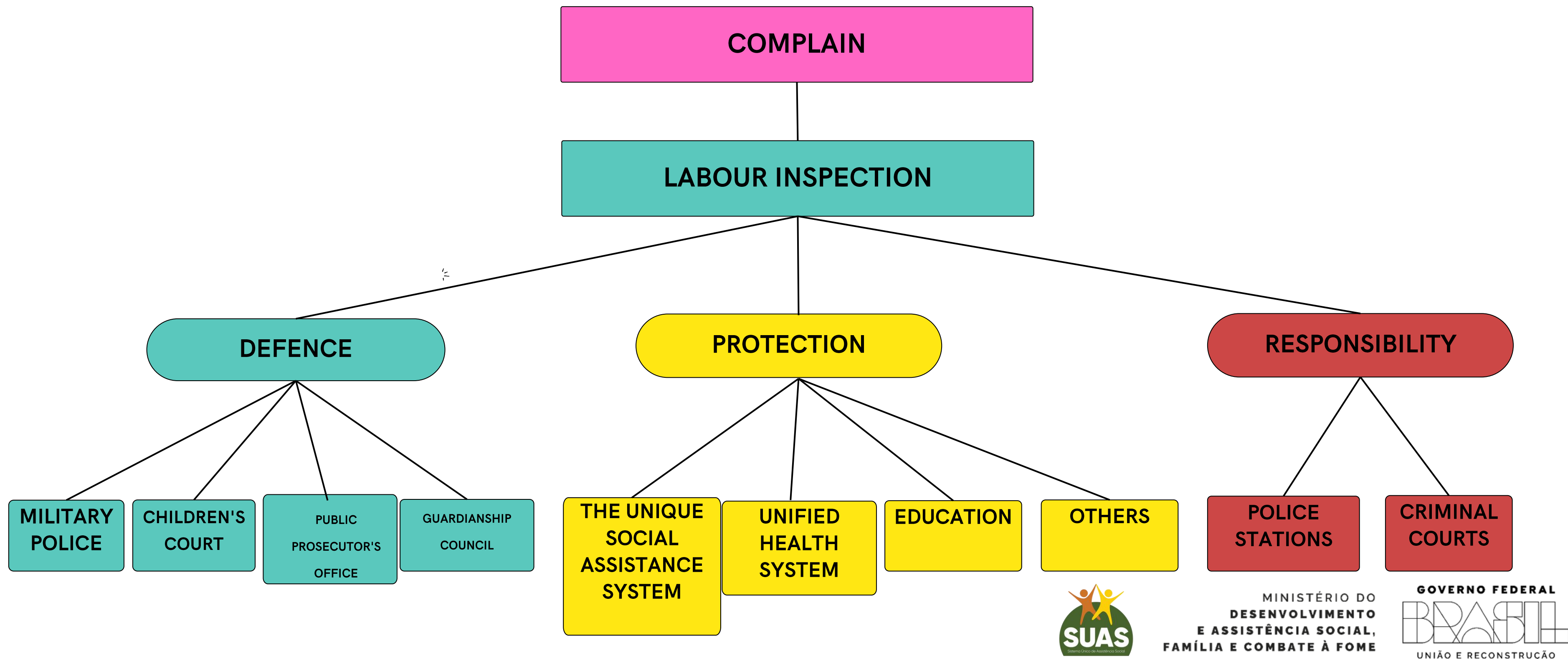

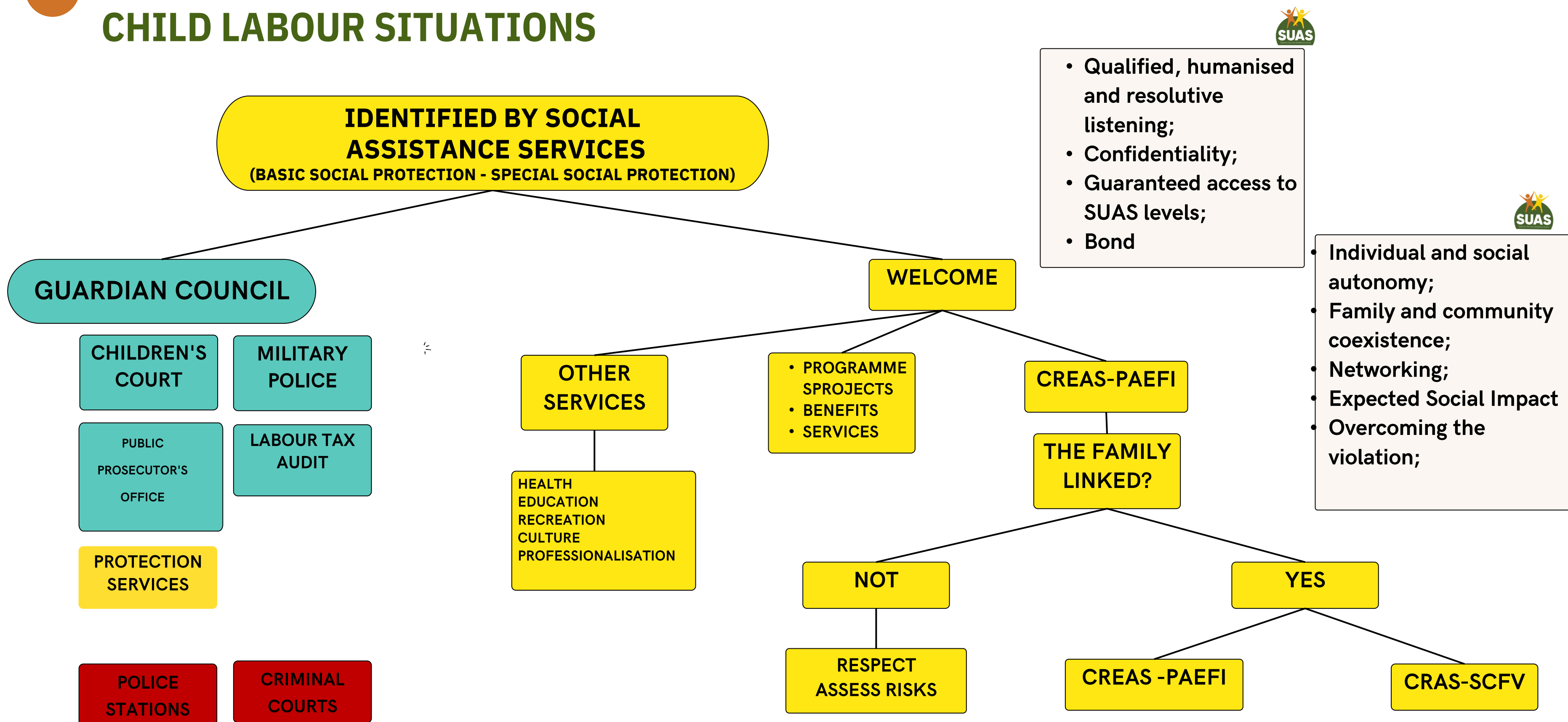


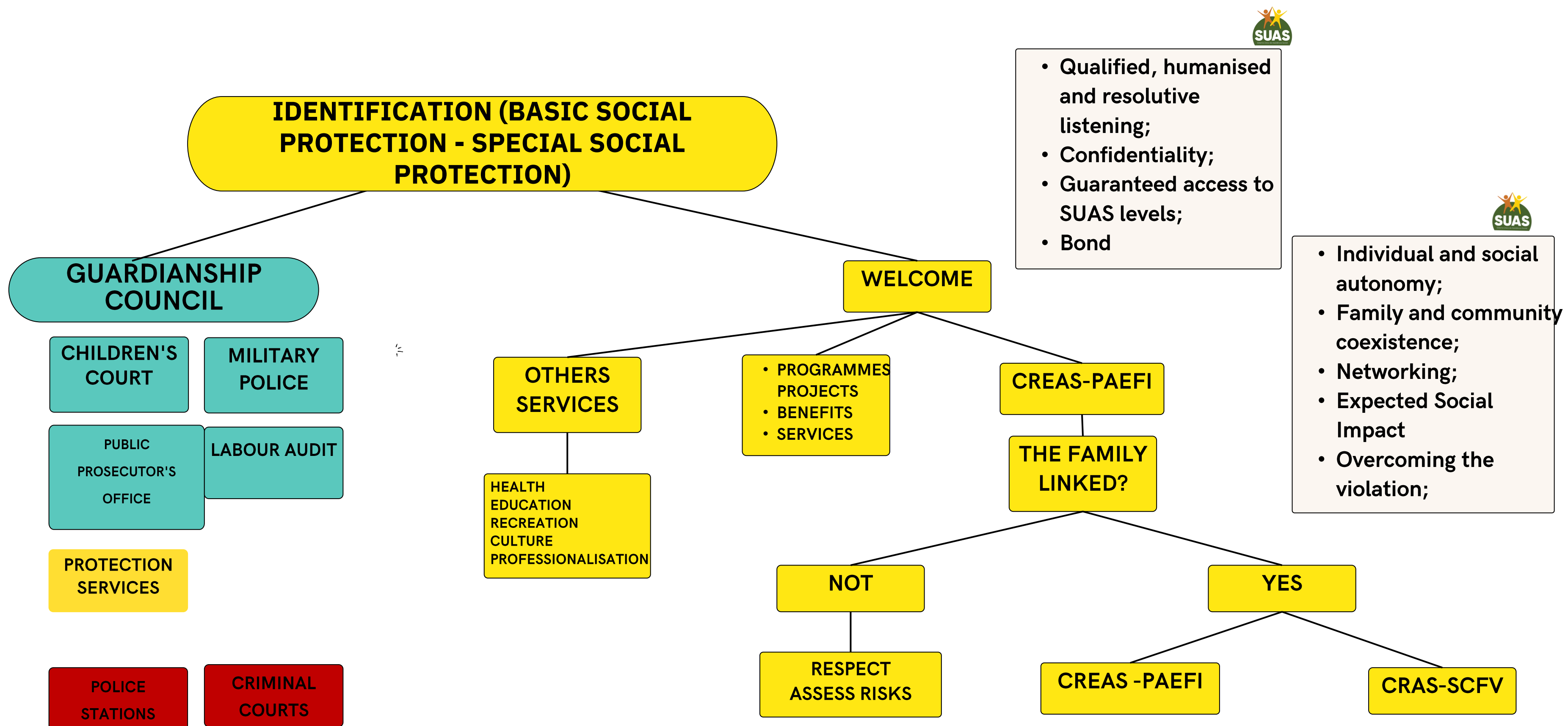

The conditionalities exist to **reinforce access to rights** in the areas of education, health and social assistance, and to **identify vulnerabilities** that are hindering families' access to these rights.

HEALTH

- **Vaccinations** (age will be stated in the ordinance, but the recommendation is to vaccinate all children under 7);
- **Nutritional monitoring** (weight and height) of children under 7;
- **Pre-natal care** for pregnant women.

EDUCATION

- Minimum monthly school **attendance of 60%** for beneficiaries aged 4 and 5;
- Minimum monthly **attendance of 75%** for beneficiaries aged 6 to 17
