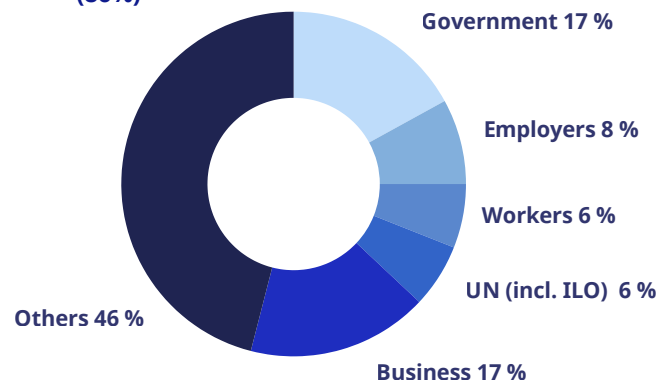


Geographical distribution of participants of online courses and self-guided online courses
