United Nations Development Assistance Framework

The United Nations Development Assistance Framework (UNDAF) is a programme document between a government and the United Nations Country Team (UNCT). It outlines the collective actions and strategies of the United Nations system to the achievement of national development goals. A Common Country Assessment (CCA) document is both a process and a product, which is used by the United Nations and its agencies to analyse the national development situation and identify key development issues. These actions and strategies can include or contribute towards the elimination of child labour.
