Follow-up to the decision to report on the modalities of the Working Party on the New Social Contract for Our Common Agenda

Addendum: Proposed road map as amended

The roadmap should be implemented with the necessary flexibility to respond to the evolution of the World Social Summit process. The Working Party will meet as necessary to ensure the provision of timely inputs, where possible in person.

- **April 2024**

- 10 April: The members of the Working Party are nominated by the three groups.
- At its first virtual meeting at a date to be confirmed, the Working Party elects its Chairperson, and two Vice-Chairpersons and agrees on a work plan.

- **June 2024**

- GB 351st Session (15 June 2024) the Governing Body adopts a “statement” prepared by the Office and the Working Party on the basis of the Conference discussions on the report of the Director-General. The adopted Statement and the report of the Director-General are transmitted to the co-facilitators.
- The Governing Body instructs the Working Party to prepare the draft key messages of the tripartite input, for approval at its 352nd Session (October–November 2024).
- Last week of June 2024 at a date to be confirmed: the Working Party meets to prepare the draft key messages of the tripartite input.

- **October–November 2024**

- First week of the 352nd Session: The Governing Body meets as a Committee of the Whole to exchange views on the draft key messages as presented in the report of the Working Party.
- Second week of the 352nd Session: The Governing Body adopts:
 - (i) the key messages of the tripartite input prepared by the Working Party;
 - (ii) a resolution on the tripartite input to the World Social Summit, which could be revised at its 353rd Session (March 2025), should the Governing Body decide so, and instructs the Director-General to transmit it to the co-facilitators and the secretariat leading the preparations of the World Social Summit.

- **Between November 2024 and March 2025**

- The Working Party meets to prepare, with the support of the Office, an update on the World Social Summit process to be submitted to the 353rd Session (March 2025) of the Governing Body.

- **March 2025**

- First week of the 353rd Session: The Governing Body meets as a Committee of the Whole to exchange views on the report of the Working Party. The Co-facilitators will be invited to join this discussion.
- Second week of the 353rd Session: Based on the reports provided by the Working Party and the Committee of Whole, the Governing Body might decide to amend the Resolution it has adopted at the 352nd Session for transmission to and adoption by the Conference at its 113th Session (2025).

- **June 2025**

- At its 113th Session, the Conference examines and adopts a resolution concerning the tripartite input to the World Social Summit, subject to the decisions taken by the Governing Body at its 353rd Session and instructs the Director-General to transmit it to the co-facilitators and the secretariat leading the preparations of the World Social Summit

- **October–November 2025**

- At its 355th Session (October–November 2025), the Governing Body discusses the follow-up to be given to the outcome of the World Social Summit.
