Overview of THB-FL elements 3Ps + International cooperation

ALL action addressing Trafficking in Human Beings, (THB) and Forced Labour, (FL) (R203 to the 2014 ILO Protocol)

- ▶ Prevention
- ▶ Protection
- ▶ Prosecution (wider sense i.e. access to justice, remedies, enforcement)
- ▶ +
- ▶ International cooperation
- ▶ Freedom from Forced Labour – Fundamental Labour Right (C29/C105)



PREVENTION:

Targeted Information campaigns

E-leaflet, video mp4 in ALL inter-city trains in Ukraine, ILO UKR colleagues, Ukrainian Railways, Trade Union of Railways and Railways Construction Workers and Kyiv Regional Council of Trade Unions (commenced in April , approx. 45-70.000 people reached/month)

Leaflets/brochures in Ukrainian (100.000 in Ukraine and 2000 in Moldova, distributed by SLS/MSLI)

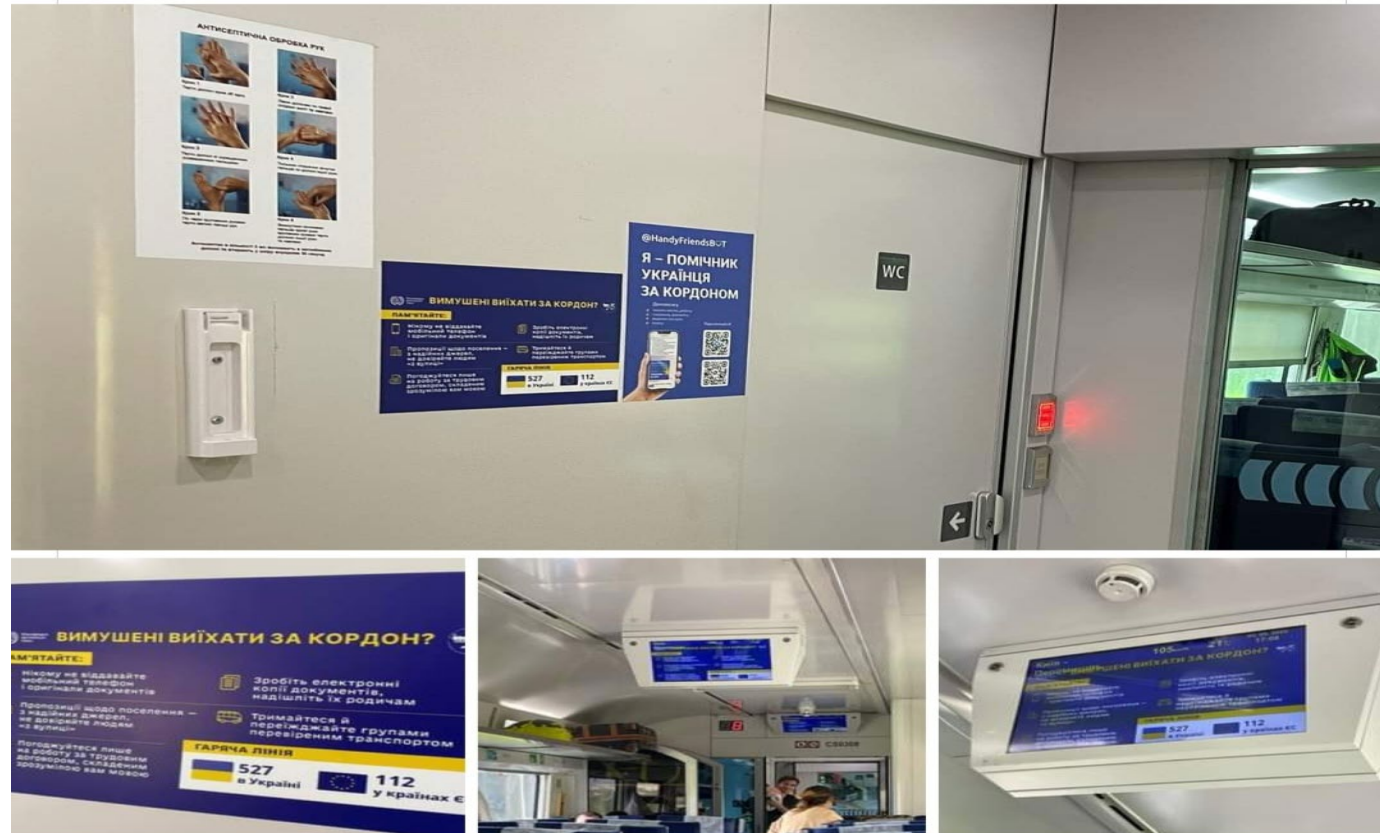
Posters in transportation hubs (1700 pcs. displayed railway stations, bus stations, distribution of humanitarian aid points, RACs)

Safe and legal migration/labour opportunities, PROFBUD website

Currently developing video and audio clip – importance of radio/media of choice in certain areas

PROTECTION

SLS presence in all transportation hubs, distribution points, community meetings (over 300.000 reached through interventions so far) www.pratsia.in.ua web portal assisting displaced/relocated with labour related advice & “UKRAINE WORKS” campaign

Consultations with Employers/Business, sensitisation trainings – Responsible Business Conduct, translation of ILO Handbook on FL/code of conduct (s) based on Guiding Principles Plan of Action/IOE, ACTEMP, Global network against FL

Reducing vulnerability – reducing risks (UDW, registration, formalisation/informality)

Psycho-social first aid (10 +3 trainings = 200LIs, 70 NTSEC Secretariat/regional, ME, Workers and Employers, next round with 5 more training and pilots in 3 enterprises)

Next steps: Regulation of Private Employment Agencies (PEAs), ILO C181 ratified by UKR/MD/HU, WEC/CIETT code of conduct, Fair recruitment...

answers

For IDPs, how to look for a job safely

Recommendations: How to work safely

► PROSECUTION (access to justice, remedies, enforcement, referrals)

Training of Labour Inspections on indicators, identification (Ukraine ongoing, ILO online workshops, Moldova recently ALL MSLI were trained on indicators and legal concepts and identification)

Labour Inspection and Law Enforcement cooperation - Joint trainings (e.g. Moldova within the so-called multi-disciplinary teams)

Role of Labour Inspectors and social partners reflected in the NAPs, NRMs

ADVOCACY – Fake job advertisements (perception is that some 50% on social media, according to UKR refugee focus group conducted by UNHCR in HU)

Thematic inspections (sectors AT RISK such as construction, hospitality/hotels, care industry and agriculture)

INTERNATIONAL COOPERATION

**Meeting of Labour Inspectors UKR/MD + EU destination countries + European Labour Authority (ELA)
– Plan of action to reduce the risks of THB-FL (possible meeting Fall 2022 in Budapest organised by the ILO)**

Possibly joint campaigns – thematic inspections across the destination countries

Working with Employers and Business on cooperation to address THB-FL, raise awareness and develop possible plan of action

Working with Trade Unions on safe migration – safe/legal employment opportunities, campaigns to raise awareness on THB-FL
