RESOLUTION

The Steering Committee of the EU-ILO Project “Enhancing the labour administration capacity to improve working conditions and tackle undeclared work” (Project SC) having discussed the items in accordance with the agenda of the second sitting (see Annex 1) agreed on the following:

I. As regards the implementation of the selected EU directives on OSH and labour relations:

- 1) with reference to the analysis of the degree of concordance between the national legislation and the selected EU directives on OSH and labour relations, as well as to the key findings and recommendations on the implementation of the EU Directives on OSH and labour relations, the Project SC considers important to give the priority to drafting the umbrella law on OSH implementing the EU Framework Directive 89/391 EEC in order to ensure the uniform basic standards and requirements to all sectors, all types of work and all workers; to lay down the grounds for the subsequent implementation of the more specific OSH directives; to simplify the national legislation on OSH;
- 2) The MSP is encouraged to initiate drafting of such an OSH law, transposing the EU Council OSH Framework Directive 89/391/EEC, based on tripartite consultations;
- 3) The Project SC invites the Project team to provide, if requested, further consultations and advise during the drafting phase;

II. As regards the national legal framework on labour inspection and international standards:

- 1) The Project SC encourages the government authorities and social partners to participate in the tripartite seminar on labour inspection legal framework to discuss the recommendations produced by the EU-ILO project report in this regard (**21 June 2018**).

III. As regards the modernization of the SLS information system:

- 1) Considering the urgent need for modernization of the SLS information system, the Project SC recommends the Ministry of Social Policy, State Labour Service, in coordination with the EU-ILO Project, to explore the opportunities for funding the effective development and implementation of a modernized information system for labour inspection (including both the software and the required hardware to support it) from the state budget and/or from potential donors.

IV. As regards the fight against undeclared work:

- 1) The Project SC acknowledges that the undeclared work is a complex problem to be tackled based on multilateral collaboration of various governmental authorities and social partners under the leadership of the State Labour Service. Therefore, the MSP, SLS encourages the Ministry of Economy, State Regulatory Service, State Fiscal Service, Social Insurance Fund, Pension Fund, National Police and other relevant authorities and social partners to participate in the tripartite workshop on drafting the strategy to tackle undeclared work, on 4-7 June;

V. The Project SC approves the workplan for the period of June-November 2018 and encourages the stakeholders to participate in the activities planned (see Annex 2).

VI. The Project SC's next sitting is scheduled to take place in November 2018.
