Project “Effective Governance of Labour Migration and its Skills Dimensions”

The project is implemented by the International Labour Organization together with Moldovan and Ukrainian constituents, the International Organization for Migration and the World Bank. The project is part of the European Union's thematic programme of cooperation with third countries in the areas of migration and asylum.

International Labour Organization (ILO)

The ILO is the United Nations agency devoted to advancing opportunities for women and men to obtain decent and productive work in conditions of freedom, equity, security and human dignity.

Within the UN system, the ILO has a unique tripartite structure with workers and employers participating as equal partners with governments in the work of its governing bodies. With the expansion of labour migration, the ILO has an obligation and unique role to play in developing principles and guidelines for governments, social partners and other stakeholders in labour migration policy and improving practice in pursuit of decent work and social justice for a fair globalization.

Labour Migration in Ukraine and Moldova

Migration flows from the Republic of Moldova and Ukraine have significantly increased during the last two decades.

The State Statistics Committee of Ukraine Migration survey (2008) identified up to 1.5 million Ukrainians who worked abroad in the period 2005-2008. Around 3 million people made at least one trip abroad for the purpose of employment during the above period. Nearly half of them (48.5 percent) went to the Russian Federation and approximately as many to EU countries, primarily the Czech Republic, Italy, Poland, Portugal and Spain.

Figures from the National Bureau of Statistics in Moldova suggest that the labour force fell by half a million workers during the last 20 years. The main destination countries include Greece, Israel, Italy, Portugal, Romania, Russia, Turkey and Ukraine.

Labour force mobility impacts directly the skills' pools in the countries of origin and destination, thus influencing considerably their economic and social situation.

Legal labour migration can be a win-win solution for both home and destination countries, as well as for individuals, while irregular migration exposes migrants to the risk of exploitation.

The development and implementation of rights-based migration policies and programmes is essential in governing labour migration.

Effective Governance of Labour Migration and its Skills Dimensions

The Project “Effective governance of labour migration and its skills dimensions” in Ukraine and Republic of Moldova will seek to develop the capacity of relevant actors in the Government, Parliament and Workers’ and Employers’ organizations to contribute to adequate migration management.

Main objectives and key activities

Strengthening Moldova and Ukraine’s capacity to regulate labour migration and promote sustainable return, with a particular focus on enhancing human resources and preventing skills waste, by:

Building capacity to analyze the skills shortage and oversupply as a result of migration:

- ♦ increase knowledge of migration and skills data through migration survey modules to be included in the Labour Force Survey;
- ♦ organize a workshop to align data collection methodology to EU and ILO standards;
- ♦ undertake a study on the link between migration and education;
- ♦ support a study on the impact of migration on a specific profession, particularly affected by migration (teaching professionals).

Enhancing the capacity of migration sending countries to balance migration flow and return with local and international skills needs:

- ♦ analyze vacancies and skills needs in Moldova and Ukraine and EU countries of destination;
- ♦ carry out occupational skill analysis and design occupational profiles in line with national and international labour market demand;
- ♦ test mechanisms for the recognition of prior learning;
- ♦ collaborate with Diaspora associations for distributing information on job and business opportunities in Moldova and Ukraine.

Building capacity to negotiate and manage rights based labour migration schemes, including agreements on social protection:

- ♦ review national legislation on social security;
- ♦ carry out training on design, negotiation and implementation of social security agreements;
- ♦ organize “Speaking days” with countries having social security agreements or negotiations in progress.

Building capacity to govern labour migration, by enacting relevant legislation and engaging social partners:

- ♦ organize a workshop for policy makers and other stakeholders to disseminate best practices in labour migration management from the EU and elsewhere;
- ♦ undertake a study visit to Brussels for key stakeholders to meet the relevant European Commission services;
- ♦ implement initiatives on social dialogue, including a study visit to Italy, support to tripartite advisory bodies on migration, creation of networks of workers’ organizations;
- ♦ review and update studies on private employment agencies and make proposals for mechanisms and sanctions to deter unethical recruitment;
- ♦ raise awareness on ILO Convention 181 on Private Employment Agencies.



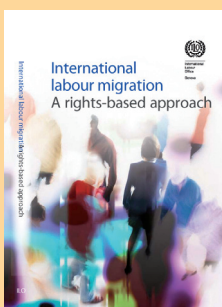
