Ladies and Gentlemen

It is for me an honor and a real pleasure to address this salient audience on the occasion of the official launch of the employment component of the major Kumba-Mamfe road development project. On behalf of the Assistant Director General and ILO Regional Director for Africa an of all the DWCT team in Yaoundé, I would like to reiterate to you the honor we feel for being a privileged partner of the Ministry of Public Ministry of Economy, Planning and the Works. Development, The Ministry of Habitat and Urban Development and many other national institutions in the implementation of employment intensive investment approaches for job creation and poverty reduction.

As you are all aware, by drawing lessons from the implementation of its first poverty reduction strategy, the Government of Cameroon is for the first time fully engaged in the formulation and implementation of a long-term development Vision. This Vision, which projects an image of the country up to 2035, aspires to make of Cameroon *a democratic emerging state, united in its geographical, linguistic and cultural diversity. More specifically,* the Vision constitutes a reference framework for: (i) reducing poverty to a socially acceptable level; (ii) moving to an effective middle-income country status; (iii) becoming a newly emerging country; (iv) strengthening the national unity and consolidating the democratic process.

These specific objectives are translated into the orientations of the Growth and Employment Strategy Paper (GESP) for the 2010-2020 period, that covers the first ten years of the long-term Vision. The main issue concerning the implementation of GESP will be to focus on growth acceleration, the creation of formal jobs and poverty reduction. It is, therefore, expected to: (i) increase growth to an annual average of 5.5% over the 2010-2020 period; (ii) reduce underemployment from 75.8% to below 50% in 2020, with the creation of tens of thousands of formal jobs every year in the next ten years; and (iii) reduce the monetary poverty rate from 39.9% in 2007 to 28.7% in 2020. To achieve these objectives, the Government intends to implement in a coherent and integrated manner: (i) a growth strategy, (ii) an employment strategy, and (iii) a strategy to improve governance and central government's strategic management.

#### Distinguished guests, Ladies and Gentlemen,

The ILO Decent Work Agenda (DWA) and the Decent Work Country Programme (DWCP) for Cameroon are consistent and in line with the three pillars referred above. The ILO DWCP strategy will foster inclusive growth by focusing on decent job creation as the best way out of poverty.

Taking advantage of infrastructure development component, the ILO's intervention will focus on the development of the small scale contractors, capacity building of local governments and institutions and the use of local resources, human and material, to deliver secondary and tertiary infrastructures that are by their nature employment intensive.

The Kumba-Mamfe road development project, jointly funded by the Government of Cameroon, the African Development Bank and the Central Africa States Development Bank, offers an excellent opportunity for the Government and the Africa Development Bank to apply their new approach and commitment to make employment, particularly the youth employment a central concern of their development agenda. To assist in achieving so, the Government through the Ministry of Public Works has signed an agreement with the ILO aiming at:

 Developing the capacity of local government to integrate labour-based approach and techniques into the public works decentralized investment programmes;

O Strengthening the capacity of local administrations in planning and managing secondary and tertiary infrastructure

construction and maintenance;

 Train the youth of project intervention zones on labour-based techniques in the perspective of post-rehabilitation

programmes;

- o Introduce and demonstrate the feasibility of technological alternatives that favour the access of small contractors to works and in encouraging sub-contract in the procurement documents;
- Reinforce the delivery capacity of the small contractors of the region for them to take advantage of public procurement of medium and small seize works;
- Put in place youth based rural roads committees able of taking responsibility of the maintenance programmes;

 Adopt and implement a participatory approach in planning, monitoring and implementation of the employment component of the project.

### Honorable Divisional Office, Ladies and Gentlemen,

Since the 1<sup>st</sup> of April 2014, the ILO put in place its project team to in charge of:

• Identify critical tasks that should be taken for the successful establishment of the Project.

• Ensure overall substantive conception, planning, implementation,

• Take the necessary steps to ensure the operationally of the project, administrating daily operations to ensure effective project implementation;

• Prepare work plans, progress reports, budget and budget revisions

in a timely manner;

• Collaborate with the technical monitoring committee an liaise with all relevant stakeholders to ensure achievement of the project

objectives;

• In collaboration with ILO EIIP specialist and Programming Unit, draft the terms of reference for national and international consultants, identify and select the consultants, and monitor and review their assignments;

• Keep the representatives of the Steering Committee informed on a

regular basis of the progress of the Project;

Organize appropriate training activities in collaboration with the identified partners

• Ensure that the project resources are used efficiently
