#### **Background**

The Virtual Policy Network on Youth employment (VPNYE) was developed within the context of the Caribbean Countries implementation of the Sustainable Development Goals 2030, and more specifically within the UN United Nations Multi-Country Sustainable Development Framework in the Caribbean. Convened by ILO, UNESCO along with CARICOM and the Caribbean Employers' Confederation (CEC) the network aims at ensuring youth employment is at the centre the national policy discourse, through intensified learning and promotion of well-informed and evidence based practices.

#### **Contents**

The idea of the webinar is tackle the labour demand side of the youth employment issue and present Caribbean and international experiences aimed at promoting output and employment growth in specific sectors as well youth led enterprises operating therein. ## **Presenters**

**Uma Ramakrishnan** is an assistant director in the IMF and Division Chief of the Caribbean II Division in the Western Hemisphere Department. She has been mission chief for Jamaica since May 2015.

**Joyce Wong** is an economist in the IMF's Western Hemisphere Department, currently working on Jamaica. Her research has focused on drivers of female labour participation, financial inclusion and development, and immigration.

**Sebastian Acevedo** is an economist in the IMF's Western Hemisphere Department, and works on the Ecuador desk. At the IMF, he worked for six years in the Caribbean covering topics related to natural disasters, economic growth, productivity, tourism, debt, and exchange rate regimes, with a particular focus on small islands. Hayden Blades is the former Senior Economist of the RBTT Group with over 12 years of experience in the financial sector. He has published economic analyses of public interest in newsletters, trade association journals, and the daily newspapers. Previously, he served as a Risk Manager in the Group Risk Management and Finance Division of RBTT Financial Group Limited. He has been involved in the review of debt financing requests from a number of the RBTT overseas territories, particularly Jamaica, the OECS, and the Netherlands Antilles.

**Lwanga Evans** is the Project Manager for the ILO Zambia Green Jobs programmes. He has over 20 years of experience in small enterprise and entrepreneurship development focusing on economic empowerment for youth and women and private sector development in sub-Sahara Africa.

**Wayne Chen** is the founder of the Super Plus Food Stores, a Jamaican island-wide chain, which at its peak in the mid-2000s was the country's largest retailer. He is the recipient of several awards for business accomplishment and philanthropy including the Jamaica Observer's 1998 Business Leader of the Year and Irvine Hall, UWI's 2006 'Distinguished Torchbearer' award. Present and past roles include Chairman of the Southern Regional Health Authority, CVM Television, NCB Insurance Company, and NCB Cayman, a former member of the CARICOM HRD Commission, and former Chairman of Jamaica's Urban Development Corporation, National Land Agency, and National Gallery. He is also a director of the National Commercial Bank, Jamaica's largest, and its majority shareholder, AIC (Barbados) and President of the Caribbean Employers' Confederation.
