13.30-15.30 Session 2. Sustainable employment creation strategies

An important feature of policies for sustained, inclusive and sustainable economic growth is employment creation policy. Moving production and work opportunities from low productivity activities in the informal and agriculture sector into higher productivity activities in manufacturing and the service sector is central to sustained growth in Indonesia. This process of transformation requires faster job creation in the formal non-agricultural economy and also sufficient stability in job tenure and incomes to encourage investment in skills and improved productivity by employers and workers. Tripartite discussion on reforms to the package of policies needed for such a balance can help to shape effective and fair results.

16.00-17.30 Session 3. Increased productivity through Vocational Education and Training

There is broad consensus that Indonesia needs to upgrade its investment in human capital as part of a drive to increase productivity through diversification, technological upgrading and innovation. In the past increased investment in education and vocational training has not produced the rates of economic and social return that were expected. This session will focus on skills competencies, apprenticeships and improvements to the current vocational training system and access to education and vocational training to increase productivity, in order to match the labour supply and the global & national jobs demand.

**Session 5. Sustainable wages policy through social dialogue for decent work and economic growth**

*Collective bargaining is a key means through which employers and workers can establish fair wages and working conditions that go beyond the legal minimum. It also provides the basis for sound labour relations. This session will consider how the potential for a broader coverage of collective agreements could be achieved in practice. The discussion will focus on what additional labour laws, labour institutions and changes in bargaining practice are required to extend collective bargaining.*

**Session 6. Enlarging social protection for inclusive economic growth**

*Indonesia strives towards the extension of social protection coverage to its population by working both on the provisions of social services and infrastructures and the development of social security. The further development of social protection for vulnerable communities and workers in the formal and informal sectors shall also be considered. Laws on the termination of employment and non-standard forms of work need to interact with social protection systems that provide adequate income security for displaced workers. This session will discuss aspects of employment protection provisions in Indonesia, including contract work, outsourcing, severance payments, the provident fund and the possibility of a comprehensive unemployment insurance scheme.*
