

I. INTRODUCTION

Zamboanga City- also known as Asia's Latin City in the island of Mindanao, Philippines consists of 98 Barangays with 2 Congressional Districts is a highly urbanized City and was rated as top 5 Riches City in the Country. In September 2013, fighting between the Armed Forces of the Philippines and rebel group in the port city of Zamboanga forced 120,000 people – primarily minority Muslims – to flee. Despite the Humanitarian aid coming from the local, national and international communities for almost Three (3) years now, still thousands remain displaced, unproductive and living in deplorable conditions. As part of the government's Road to Recovery Program after transferring them to the transitory sites and or permanent shelters was to provide them with livelihood and facilitate employment for skilled individuals. The Four (4) affected Barangays where the transitory shelters are located namely; Tulungatung, Sta. Catalina, Mampang and Tigtabon.

The aim of the Joint Project is fostering sustainable development and revenue generation in the targeted communities by providing skills training to facilitate employment for the beneficiaries. The skills training on food processing for 200 internally displaced persons (IDP's) of Zamboanga City was made possible through the collaborative efforts of the Department of Social Welfare and Development (DSWD), Technical Education and Skills Development Authority (TESDA) and the Century Pacific Foods Inc. (CPFI) funded by the International Labour Organization (ILO).

The DSWD being the front liner in the delivery of basic services to the vulnerable sectors of our society and as the lead government agency in the implementation of this project of which the main responsibilities is the identification and profiling of potential beneficiaries for pre-employment training to be recommended to TESDA, provide soft skills training, facilitate in the conduct of orientation and exposure cannning factories and monitoring their status of employment.

The TESDA as the lead government agency that gives technical and skills training and assessment to interested individual and provide them the necessary expertise and support in searching for potential employers to certified trainees.

The Century Pacific Foods Inc. is committed to provide employment opportunities to the TESDA graduates as top priority. These areas of cooperation was put into action after the signing of the Memorandum of Agreement with the presence of the Regional Director of DSWD ATTY. ARACELI F. SOLLAMILLO, TESDA Regional Director Sir Lorenzo G. Macapili and CPFI Plant Manager Mr. Ariel S. Onesa. Also present was the International Labour Organization (ILO) Project Coordinator for Zamboanga City Ms. Rizalyn Vale.

II-IMPLEMENTATION

DSWD after series of coordination with partners and meeting among staff had come up with the list of 200 potential beneficiaries and schedule of orientation, exposure and training. As agreed during the MOA signing, the participants were required to undergo one day orientation on company's Rules and Regulations and Good Manufacturing Practices (GMP). They have also undergone one day exposure/on-the-job training with 7:00 AM-7:00 PM work at the factory before undergoing the 15-day training by batches. The 200 participants were divided into 3 batches at 1st batch-66 May 16-27, 2016, 2nd batch-67 May 30-June 17, 2016 and 3rd batch-67 June 20-July 8, 2016. The TESDA provided Two (2) Trainors to handle per batch within May-July, 2016. The 15-day training package covers the following; 5-day soft skills which includes personhood, personal development and hygiene and basic communication skills. Another 10 days focused mainly on Food Processing and Handling. Each Trainor handles 33-35 participants per batch. The participants have their turns in listening to the different topics or lectures and actual demonstration on how exactly the food is being processed. In general the participants were very participative during the whole duration of the training except for some minor but manageable cases. The participants learned the different methods and processes especially on food preparation, preservation, packaging and handling.

III-ASSESSMENT OF JOINT PROJECT RESULTS

During the culmination activity of each batch, the participants were being assessed and all 200 participants passed the assessment from TESDA as the participants showed great interest during training manifested by their complete attendance and active participation. The most significant event of the joint project was the Simultaneous Graduation Ceremony of the 200 participants with their relatives also present during the occasion. It was the time they met very important people behind the project and hear words of encouragements and inspiring messages. Present during the graduation ceremony were; Ms. Rizalyn Vale from the International Labour Organization (ILO)-Funder gave the welcome remark putting emphasis on dealing with life's challenges on the daily basis and living every single day productively without worrying what is still to come because what we have accomplished today will shape our future, DSWD IX Assistant Regional Director for administration Sir. Riduan P. Hajimuddin expressed his heartfelt gratitude to the different partner for their involvement to the joint project and thanked the funding institution, the ILO led by Ms. Rizalyn Vale, Project Coordinator for Zamboanga. He also congratulated the 200 participants for their perseverance in facing life's challenges, TESDA IX Regional Director Sir Lorenzo G. Macapili gave a message focused on developing one's self continuously. Don't be contented with the skills that you have, instead study more read more and more. The Center Head Mr. Geronimo A. Bandico presented the 200 graduates to Mr. Lorenzo G. Macapili and as the TESDA Director declared the participants graduates for skills training on food processing. The Plant Manager of Century Pacific Foods, Inc. Mr. Ariel S. Onesa gave his commitment to hire the 200 TESDA graduates on top priority. Also present during the

ceremony were DOLE representative Ms. Sylvia Delos Santos, LEO III, TESDA instructors; Ms. Gemma Ituralde and Ms. Sheva Fuentevilla. PDOs. Mr. Rodolfo A. Espiritu Jr., Nursida T. Sarail, Aldrich Anastacio and Roland S. Alojado. One of the participants Mr. Margami Suraji, gave a testimony on how fortunate he is to be part of the 200 graduates for the opportunities that were given to them especially the learnings that was imparted, free training fees, free meals, transportation allowance training kits, certificates and T-shirts. He also made special mention to the two TESDA instructor to thank them for bearing with them during the whole duration of the training.

IV. GOOD PRACTICES AND LESSONS LEARNED

All the key players of the joint project had given their best part and was able to work as a team thereby producing successful results. Guaranteed employment to the Century Pacific Foods, Inc. and 8 other Canning factories are also open for hiring TESDA graduates being part of the Industrial Group of Zamboanga Inc. as committed by the Plant Manager of CPFI being the president of the Industrial group. The presence of regular PDOs who have access to Company's HR and Man-power Cooperatives for easy monitoring of Hired beneficiaries. The partners are now more engaged and a good number of cooperative efforts have been documented. However, it was widely acknowledged that these types of synergies (among governmental partners and at the local level) should have been facilitated and articulated in a more formal manner. As this project was part of a coordinated effort, another key success factor has been in establishing partnerships and synergies with the other partner agencies in order to pool resources and give greater support to common objectives by establishing joint activities. The joint project represents an innovative approach; which combines in an integrated manner initiatives to improve the quality of life of the IDPs through community development and empowerment not the usual way of doing things "DOLE-OUTS". There were some constraints including delays during project implementation like the delay in recruiting the 2 Project Development Officers for 2 month. Some changes in the MOA (addendum) on the roles and functions of the partner agencies. In addition, the procurement process also add to some delays especially the needed materials for training (consumables).

Main mitigation actions implemented to overcome these constraints, several coordination meetings and workshops are to be arranged between implementing partners in order to maximize benefits to avoid delays and/or overlapping of activities. The Project must come up with approaches to vastly adapt to the changes keeping shorter communication and decision making lines, to fast track hiring of needed personnel, more frequent meetings and higher coordination between the partners. The team should worked closely with all involved partners to complete the activities with a result-oriented vision.

V-EMPLOYMENT STATUS

Attached is the list of 200 IDP's Graduates and the list of Graduates reported by Great Hands Cooperative who graduated from TESDA who are now employed with Century Pacific Foods, Inc. (CPFI). For Batch 1 and 2. Batch 3 are still preparing their needed requirements and are scheduled to apply 2nd week of August, 2016.


IV. FINANCIAL STATUS OF THE JOINT PROJECT


