

MIRD BASELINE DATA

Barangay Kasanyangan

December 2015 (1st week)

Kasanyangan Transitory site is one of the 11 identified transitory sites in the city with a total number of 290 IDP families or 1,781 individuals. These families is originally coming from the place of Mariki, Riohondo, Sta. Barbara, Sta. Catalina and Kasanyangan (*Source: CSWD as of November 14, 2015*).

Out of this figure, we are targeting 50 IDP beneficiaries for the skills training on NC-II Commercial Cooking and Carpentry. We have gathered and collected their data for profiling and for monitoring purposes.

Out of the 50 target beneficiaries majority are male which is 58 per cent. It is because there are four men that are interested to avail skills on commercial cooking

Livelihood/Skills Trainings from Government and NGO

The International Commission on Red Cross (ICRC) is present in the site. Their programme is on providing skills training to Youth. They already have selected 35 youths for various skills training in a school-based short course programme. They are providing conditional financial assistance distributed in two tranches. First release is for school enrollment, miscellaneous and transportation. The second tranche is given after successful completion of the trainees to purchase starter kits, process legal documents and payments for national certification assessment. ICRC also provides livelihood grants to the 139 most vulnerable IDP families in the transitory site. Another Cash for Work Programme on Mangroves planting on 15 days duration at Php280.00 per day with a total of 50 beneficiaries.

Educational Status

For the whole transitory sites data below shows that there is a higher literacy rate among youth or 89 per cent are in school.

For our target trainees, we look into the educational attainment of at least high school graduate to qualify for the set criteria and comply with the TESDA NC-II qualification.

Health and Sanitation

There is no community clinic or assigned health worker at the site. When family members got sick and there is a need for medical attention they have to bring it to the barangay health center few kilometers away or to the medical hospital located at the city proper.

There is comfort rooms found in every lane of the houses, each unit is being shared by a number of families. Supply of water came from their non-IDP neighbors within the Kasanyangan. Water is on schedule basis; you have to pay Php70.00 per hour of water connection regardless of the volume of water each of the household gets. To conserve water, the family must have to limit the usage of water for bathing, washing and cooking.

Though there is a communal facility in the site, it is noticeable that a number of households still dump on their leftover foods and water waste to the ground because their houses is built on stilt. Community members say that the city government held an environmental awareness orientation.

Current State of income

Based on the data gathered during the assessment of our 50 target beneficiaries, their current income or livelihood sources are through jeepney and pedicab driving, buy and sell, sari-sari store, rice trading, side walk vending, food vending and carpentry that are not stable.

Current situation of the transitory and IDPs (before we enter to the community: aspirations)

Walking along a 100 meters or more of muddy-clay soil from the hi-way under the heat of the sun, passing the boardwalk we saw about 30 units of houses-on stilt that is being built just on the other side of the temporary shelter. On the front row, we saw the CCM Command Post and next to it is another unit that sells a blue jar container of refilled mineral water. All temporary units are occupied. You can see a small extension from some part of the houses that are used as sari-sari store and washing area.

There are plastic blue drum outside of more than 200 houses provided by International Organization for Migration (IOM). There is a warehouse built by IOM and it is also used as prayer room of the Muslim elders, at the same time it is

accordingly intended for activity center. When you walk-through inside the community you will see small mosque and a number of stalls selling variety of cooked foods and soft drinks and other snacks items.

People seems to live back to normal life, you can see women preparing their family meal in their kitchen, washing clothes, bathing their children, some are just at home watching television shows, it's like a "mind your own business" scenario. There are group of young men who just stay and spend their time in a mosque, because they have no livelihood activities to attend to. Some group is seen playing basketball game. While you see more adults and old man carrying pieces of lumber on top of their shoulder from a warehouse distance from the transitory site, going inside the area of construction.

Aspirations

One of the man shared when he was asked why he is willing to join carpentry skills training, he answered that he wanted to acquire new skills, receive an NC-II certificate for him to be employed, earn enough to help his parents and siblings. Because his previous job was a pushcart labourer at the wet market, he used to get seawater for raw fish preservation from the boulevard loaded in his cart and push it over to his customer at the wet market. His earning is not enough to support his family and it was kind a heavy work.

There is this one lady; she lives with her bed-ridden mother and sister. She works for a living for the three of them. Early morning she cooked and sells native delicacies in their site just to support their daily family needs. She wanted to have skills training on cookery for her to learn and explore more on food preparation that she could cook and give her additional income to support her family.

Shaina, 22 years old, a baby sitter lives with her 43 years old mother and his brother. She and her mother cook and sell bananaque, while his brother help in the marketing. When they've lost her father last 2010, she force to stop schooling because of a meager earnings that is good enough for family food. She really wants to avail skills training, because she sees opportunity of having a decent job and improve her cooking skills
