





HIV/AIDS and the world of work. International Labour Conference, 99th Session 2010, Report V(1)

At its 298th Session in March 2007, the Governing Body decided to place an item on HIV/AIDS and the world of work on the agenda of the 98th Session (2009) of the International Labour Conference

for a double discussion leading to the adoption of an autonomous Recommendation. It was decided that it was necessary to adopt an international labour standard on this subject in order to increase the attention devoted to HIV/AIDS at the national and international levels, to promote united action among the key actors on HIV/AIDS, and to increase the impact of the ILO code of practice on HIV/AIDS and the world of work adopted in 2001 as well as to review developments since 2001.

Give girls a chance: tackling child labour, a key to the future

The report draws attention to the international legal framework as it relates to child labour and children's rights, and specifically to the situation of girls. It identifies the reason why it is so important that the issues facing girls engaged in child labour be urgently addressed: the hidden nature of many forms of girls' work; the special vulnerability of girls who face multiple disadvantages; the "double burden" of having to combine household chores and economic activity; and the huge indirect impact of the HIV/AIDS epidemic on child labour in general and on girls in particular.





Labour migration for development: best practices in Asia and the Pacific (Working paper No. 17)





Managing irregular migration as a negative factor in the development of Eastern Asia (Working paper No. 18)





The management of irregular migration and its consequence for development: Gulf cooperation council (Working paper No. 19)





**Mainstreaming political
participation in marginal
communities**

The study deals with the gains of the Government of the Philippines-United Nations Multi-donor Development Programme 3 (GOP-UN MDP3) at strengthening the foundation of functional democracy in the peace and development communities (PDCs). Highlighted are the individual experiences of four PDCs at building social capital for political participation most notably in the areas of identifying communal needs and resources and in evolving community-based mechanisms for policy setting and decision making and mainstreaming these efforts with the legitimate, more enduring LGU bureaucracy.
