



This collection of essays brings together the main findings of ILO research since the start of the global financial and economic crisis in 2008. With contributions


from diverse research disciplines, the volume provides new perspectives on employment and income-led growth and the role of regulation, and makes policy recommendations for the future.


### Towards widespread ratification and effective implementation of the governance conventions: labour inspection, employment policy, and tripartite consultation. Plan of action (2010-2016)



The sustained promotion of decent work requires the building national institutions and capacities that serve to promote employment while strengthening national systems for ensuring compliance with labour standards, particularly through labour inspection and tripartite consultations. This is especially important in the current context of the global economic crisis and the risks it entails in terms of a prolonged increase in unemployment, a regression in workers' protection, and deepening poverty.

### Globalization, adjustment, and the challenge of inclusive growth: boosting inclusive growth and industrial upgrading in Indonesia, the Philippines, and Viet Nam

Globalization and regional integration have been linked to trade liberalization. The findings from

Viet Nam, Indonesia, and the Philippines reveal different contextual experiences and sets of policy responses to external shocks which have affected employment and output. But there are also some interesting that underline the importance of skill upgrading, social partnerships to promote labour welfare, and proactive labour legislation, which provide the right kinds of incentives for inclusive growth.

## STUDIES ON GROWTH WITH EQUITY



### Indonesia: reinforcing domestic demand in times of crisis


The Indonesia's post-crisis economic and labour market performance has been remarkable, even in comparison with other Asian countries that have also fared well. This report examines in detail the

macroeconomic developments which occurred during the course of the crisis with particular emphasis on reviewing how the labour market has coped over this period. Indonesia was one of the few economies to have demonstrated resilience to the global crisis in terms of both growth and employment.

The study shows that the ability of this country to weather the crisis was almost entirely due to the country's reliance on a series of strong social protection schemes which were implemented after the 1997 Asian financial crisis. It also addresses the challenges which lie ahead and the areas for improvement.

### Germany: a job-centred approach

Despite a dramatic decline in output as a result of the global financial and economic crisis, Germany's labour market held up well compared with other countries. Although the economy shrank by 4.7 per cent

in 2009, more than in most other countries, employment fell by only 0.2 per cent, whereas the average for the industrialised countries was five times worse than in Germany. Socially-inclusive policies were key to Germany's success in responding to the crisis and should serve as the foundation for future action. This was the conclusion reached by the first comprehensive assessment of Germany's policy to tackle the crisis, issued by the ILO.

### Brazil: an innovative income-led strategy

The present study shows concretely how the growth-cum-equity strategy was designed and implemented in Brazil. It also analyses the extent to which the strategy helped Brazil overcome the global financial and economic crisis which erupted in the aftermath of the collapse of Lehman Brothers in 2008. The review identifies key pending challenges and formulates possible policy responses.

Brazil, while not immune to the effects of the financial and economic crisis, has fared reasonably well compared to many countries in terms of economic and labour market performance. This report examines the way in which social protection measures were utilized in order to mitigate the social and economic effects of the crisis. It also addresses the challenges which lie ahead and the areas for improvement.






