

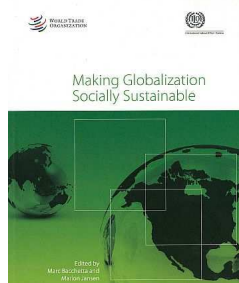

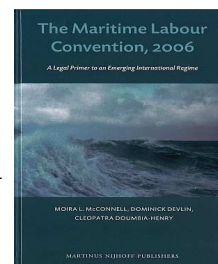

The maritime labour convention, 2006: a legal primer to an emerging international rights



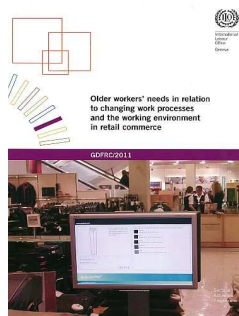
Aimed at achieving both "decent work" for seafarers and fair competition for shipowners, the Maritime Labour Convention, 2006

(MLC, 2006) covers most aspects of maritime labour. It establishes an effective enforcement and compliance system with, for the first time, certification of seafarers' working and living conditions on ships. With its interwoven labour and social rights and economic goals, the MLC, 2006 is an international legal instrument that will have a significant impact on approaches to labour standards in other globalized sectors.

Older workers' needs in relation to changing work processes and the working environment in retail commerce. GDFRC/2011

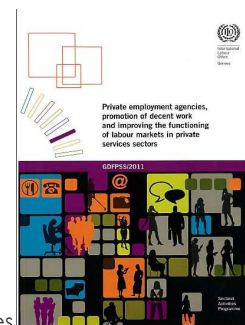
The paper focuses on the impact of the demographic transition to an increasingly aged population

Private employment agencies, promotion of decent work and improving the functioning of labour markets in private services sectors. GDFPSS/2011

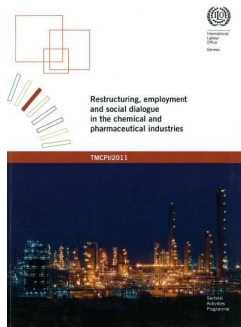


The paper aims to highlight trends in temporary agency employment in private services

CHEMICAL INDUSTRY



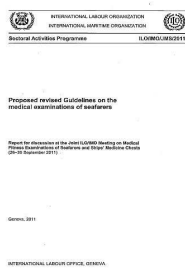
Restructuring, employment and social dialogue in the chemical and pharmaceutical industries. TMCP/2011

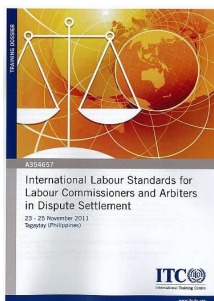
Proposed revised guidelines on the medical examinations of seafarers. ILO/IMO/JMS/2011

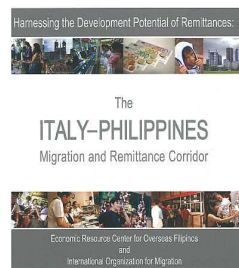

The Italy-Philippines migration and remittance corridor

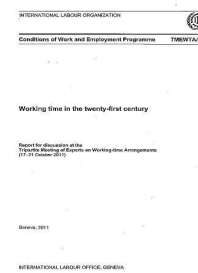

Working time in the twenty-first century. TME/WTA/2011

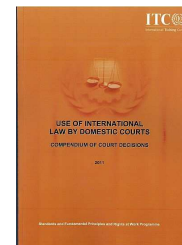
