


World social protection report 2017-19: Universal social protection to achieve the Sustainable Development Goals

This ILO flagship report provides a global overview of recent trends in social protection systems, including social protection floors. Based on new data, it offers a broad range of global, regional and country data on social protection coverage, benefits and public expenditures on social protection. The report follows a life-cycle approach, starting with social protection for children, followed by schemes for women and men in working age, including protection in case of maternity, unemployment, employment injury and disability, and those for older persons, including pensions.

Local resource-based approaches in water works

The report brings evidence from 12 projects showing the approach in different stages of the project cycle focusing on water and sanitation, small dams; irrigation systems and adaptation works. It captures ILO's experiences in the application of local resource-based (LRB) approaches to water works – water supply and sanitation services, small dams,

irrigation systems, and adaptation works at the community level in many countries covered by technical assistance and projects, either as response to pre or post-disaster and/or conflict, under the Employment Intensive Investment Programme (EIIP).

Skills for green jobs in Bangladesh

The study argues that for greening the economy, the policy should target implementation of the skills needs for green jobs in various sectors with priority to renewable energy, RMG, waste management and brick manufacture as identified by the present study; incorporate them into the occupational profiles, curriculum design and education and training provision for greening existing occupations and for developing emerging and new green occupations; and promote strategic interventions for overcoming the skills gaps.
