

Overview of Evaluation of RBSA in the ILO

November 2016

Introduction

The ILO's funding base consists of assessed and voluntary contributions. Voluntary contributions include the Regular Budget Supplementary Account (RBSA), which allows development partners to provide un-earmarked core funding to the ILO, increasing the Office's capacity to deliver and achieve results at the country level. The ILO allocates RBSA funds flexibly when and where they are most needed. RBSA resources are allocated to ODA-eligible countries only, and are aligned with the ILO's results-based framework.

How RBSA is evaluated

ILO Office Procedure Number 63 names the Evaluation Office (EVAL) as being responsible for RBSA evaluation oversight. This Office Procedure establishes the procedural steps and accountability for the use of a RBSA reserve set aside or oversight, monitoring and evaluation; the allocation of these funds and their release; and the respective roles and accountability of headquarters and regions for implementing and reporting on the use of RBSA funds for these purposes.

This reserve can only be used to finance the following:

- The establishment and maintenance of results-focused monitoring and reporting practices in the regions and at headquarters;
- The development of monitoring systems and the establishment of baselines against which to assess and report on results; and
- The conduct of independent evaluations and internal reviews of activities directly linked to RBSA allocations.

Quality control of RBSA evaluations

RBSA evaluations are included in the sample of evaluation reports that are part of regular (two yearly) quality appraisals commissioned by EVAL to external consultants. A review of these studies showed that the average quality rating of the RBSA evaluations is slightly higher than that of non-RBSA evaluations, though the difference is statistically insignificant.

Procedural steps and accountability

Regional offices are responsible for developing evaluation plans for RBSA-funded interventions. These plans indicate how the proposed activities will complement the region's evaluation work during the biennium (see annex). Regions are requested to work closely with EVAL in developing these plans.

The budget for the proposed regional evaluation plan is based on figures provided by PROGRAM. The regional plan is submitted to EVAL for approval as soon as possible after receiving such figures. PROGRAM informs the



regions as and when additional allocations are available, in which case the regions may put forward additional requests. EVAL reviews the plans in consultation with PROGRAM to ensure that the amounts budgeted are reasonable in relation to the use of RBSA in the region.

The resources from the RBSA reserve are released by FINANCE to each region on the basis of the approved plans. Regional offices submit an annual report to EVAL on the use of the resources released for evaluation activities in their regions.


Reporting on RBSA related evaluation findings

EVAL started informing the GB on the findings of RBSA evaluations in its 2010-11 Annual Evaluation Report (AER). EVAL has continued to report on it as part of the AERs through specific studies or reporting on follow-up to recommendations pertaining to RBSA in its rolling action plan.

The Evaluation Office, directly, or through its evaluation network, commissions dedicated evaluations of projects or CPOs funded from RBSA or includes RBSA funded activities in its DWCP, policy outcomes, metastudies or synthesis reviews as appropriate. Below extracts are provided of findings reported though the AERs as well as relevant reports on planned or completed evaluations.

Annual Evaluation Report - 2010-11

During the 2010–11 biennium, a significant portion of the RBSA M&E funds were used to conduct independent evaluations. As part of an effort to improve reporting on the overall performance and effectiveness of RBSA-funded initiatives, an assessment of ten RBSA evaluations was conducted based on the methodology used for a broader meta-analysis of project performance. The performance of these RBSA operations was rated based on the six performance criteria of relevance, effectiveness, efficiency, evidence of intended results, M&E and sustainability and risk management. The results are shown in figure 1.





Annual Evaluation Report - 2011-12

The review in this report looked at six evaluations of programmatic work with a sizable RBSA funded component of which four were from Africa and two were from Latin America. Five were independent evaluations and one was internal. Most covered multi-year work programmes for the period from 2009 to 2011, and most RBSA allocations from this period fell under the results framework of multiple DWCPs, so that the scope of the evaluations was mainly thematic.

EVAL conducted another meta-analysis of the ILO's performance based on the six evaluation reports' findings. The analysis criteria included: i) relevance, ii) coherence, iii) effectiveness, iv) efficiency, v) sustainability and impact, and vi) M&E framework and evidence of results.




Figure 2: Average performance rating of RBSA-funded initiatives, by evaluation criteria

All sample evaluations followed the UNEG recommended framework for evaluation and also provided useful recommendations and lessons learned. Findings relate to the six reviewed evaluation reports and have to be considered in conjunction with other reports on the overall effectiveness of RBSA funded initiatives. Most RBSA interventions (five of the six) were found to have added value to the achievement of the regional strategy and DWCP outcomes they supported. The assessment of results are presented in figure 2.

The evaluations indicated that the RBSA-funded interventions supported country programme outcomes, but were often not linked to a clear logical framework and a monitoring system. This was largely due to the uneven use of a monitoring system for the CPO to which the RBSA was linked. Most evaluations found that while the CPO's purpose, outcomes and outputs were clearly defined, measurable indicators and milestones for tracking progress were far less evident. Exceptions were RBSA allocations that supplemented initiatives funded through traditional technical cooperation projects for which logical frameworks and monitoring systems were available and aligned with the relevant CPO.

Several evaluations found that more frequent performance reporting that covers a wider range of criteria was needed for effective oversight of the CPO and for identifying lessons learned. This is strongly encouraged in the revised DWCP guidelines, but not compulsory.



Roughly half the evaluations noted that in cases where different ILO Offices were involved (CO, RO and HQ) in collaborating to deliver the RBSA-supported CPOs, there were challenges related to ambiguity over roles and responsibilities. As the ILO moves further towards allocating RBSA for CPOs, it will need to guide staff in how to merge practices previously established for either regular budget programming or technical cooperation programming.

Annual Evaluation Report - 2012-13

In the AER 2012-13 report, the assessment was based on the meta-analysis of four evaluations, of which three were cluster evaluations that covered multiple CPOs spread across different countries in the regions: two were from Africa and one was from the Americas. The fourth evaluation covered CPOs with major RBSA from the former Yugoslav Republic of Macedonia. Together, these evaluations covered 23 CPOs and two regional programme outcomes. The evaluations were scoped to assess CPOs for which a large share of support was being financed through RBSA.

The overall assessment on ILO performance, as reflected in the four evaluations, suggests that the RBSA support to the African region on promoting social dialogue and to the former Yugoslav Republic of Macedonia for complementary activities under DWCP yielded very satisfactory results. RBSA support to African countries for employment promotion scored much lower, suggesting that RBSA funds were not used to such good effect. However, performance of individual CPOs covered in the evaluations had varied levels of success. Political instability also had a negative impact on some. The ratings for RBSA allocations for forced labour CPOs in Brazil and Peru were dragged down because of negligible monitoring and evaluation and weak sustainability measures.

The CPOs that received major RBSA contributions were well designed in terms of relevance and coherence. Scores also indicated that RBSA funds were used effectively in promoting core areas of the ILO's mandate in accordance with the countries' priorities. Analysis indicates that RBSA funds have contributed to capacity building, progress towards ratifications, legislation and knowledge products with long-term impact.

The efficient use of resources was found somewhat unsatisfactory, although financial resources made available under RBSA were used efficiently in most cases once allocated. Time delays in approvals and release of other funding sources supporting the same CPO budgets were also at fault. The score on the sustainability and impact of the results is on the higher side of "satisfactory", while monitoring and evaluation and evidence of results scored lowest, due to weak monitoring and evaluation systems applied to activities receiving RBSA funds.

Overall, the results are very similar to what was found in a previous assessments that showed average satisfactory performance.

Following consecutive reporting on RBSA evaluation findings in three AERs a set of recommendations were included in the last one (AER 2013-14) and approved by the Governing Body:



Recommendation: Keeping in view the increase in outcome-based funding, EVAL recommended that the Office should update existing RBSA monitoring and evaluation guidelines or introduce new guidelines to include the planning and budgeting of monitoring and evaluation of outcome-based funded activities.

Recommendation: Country Offices and PROGRAM should weigh the potential areas of continued support under RBSA well in advance. This will help these offices to identify and prioritize early on where better results could be achieved through additional financial support.

Recommendation: CPOs receiving major RBSA contributions or outcome-based funding should be evaluated in a timely manner, preferably towards the close of the DWCP, and even as part of a DWCP evaluation or DWCP reviews, to maximize the "use of evaluation".

The Annual Evaluation Reports 2013-14, 2014-15, and 2015-16

The three subsequent AERs did not include a dedicated section on RBSA but focussed on follow-up through its rolling plan of action on follow-up to recommendations emanating from AERs. Since then annual updates have been provided to the GB. Below the latest updated provided in the AER 2015-16 is given:

Regarding the recommendation that the Office should update existing RBSA monitoring and evaluation guidelines or introduce new guidelines to include the planning and budgeting of monitoring and evaluation of outcome-based funded activities the Office responded (2016 status):

"Templates for outcome-based funding proposals and reporting have been developed and systematically applied. Evaluation practices for outcome-based funding partnerships have been agreed upon in close cooperation between PARDEV, EVAL and outcome coordinators. As regards RBSA, an internal review of this funding procedure, conducted in August 2014, provided further input for the improvement of programming and RBSA allocation within an integrated resource framework. Building on these developments, a revision of RBSA and outcome-based funding allocations and appraisal processes is underway as part of the Implementation Plan of the Field Operations and Structure and Technical Cooperation Review. As per new guidelines on RBSA for 2016–17, issued in December 2015, the appraisal and decision process is time-bound (i.e. a maximum of 15 days after submission of proposals)".

Regarding the recommendation that country programme outcomes receiving major RBSA contributions or outcome-based funding should be evaluated in a timely manner, preferably towards the close of the DWCP, and even as part of a DWCP evaluation or country programme review, to maximize the "use of evaluation" the response of EVAL was (2016 status):

"All high-level and DWCP evaluations include a review of RBSA-funded activities as part of the analysis. A follow-up the EVAL RBSA synthesis review of 2013 is still under consideration. A substantial number (29) of <u>dedicated evaluations of RBSA funded activities</u> has been



undertaken in the last 5 years as illustrated in **Annex I** and an additional 10 (Africa 3, Asia 1 and Europe 6) are planned for the current biennium 2016-17.

Regarding the recommendation that country offices and PROGRAM should weigh up the potential areas of continued support under RBSA, well in advance the Office responded (2016 Status):

"PROGRAM, in collaboration with PARDEV, continues its work aimed at streamlining the RBSA appraisal, decision and allocation mechanism, building on improvements made in 2015 in response to the findings of the 2014 internal RBSA review. The new guidelines for 2016–17, issued in December 2015, include clear roles and responsibilities for appraisal and a well-defined timeframe for the whole process".

Concluding remarks

It should be noted that all evaluations in the ILO, self-, internal, and independent, take into account RBSA funding when it is part of the funding mix. In addition, from time-to-time, the ILO conducts thematic evaluations to show how RBSA contributes to subsets of Country Programme Outcomes. Annex I contains a list of these special evaluations.
