Strategic Partnerships with pan-African institutions

Strategy for the Harmonization of Statistics in Africa (SHaSA)

- SHaSA was jointly developed by African Heads of National Statistical Offices, the AUC, AfDB and UNECA and adopted by (i) the AUC/UNECA Joint Conference of Ministers for Finance and Economy; and (ii) the Summit of Heads of State and Government of the African Union in July 2010
- SHaSA is continental effort that directly supports the African integration agenda
 - SHaSA I (2010-2016)
 - SHaSA II (2017-2026)

Technical assistance activities

- Technical and financial assistance provided for the production of 2015 Labour migration statistics in Africa released in 2017 as a joint output on labour migration programme for Africa together with the African Union Commission, ILO, IOM and UNECA
- Technical assistance provided to SADC members states with commitment made to conduct at least a comprehensive labour force survey every two years (from 5 years)
- Technical support provided with the production of labour force related reports as well as decent work country profiles

- Support provided in developing harmonized tools for the pan African institutions and regional economic communities
- Coordination of the regional capacity building activities for better understanding of the 19th ICLS resolution, data management, labour migration, work statistics, working time, informality, wage statistics and SDGs for SADC, ECOWAS...
- Continued provision of support to member States on data collection, using previous standards concerning "statistics of the economically active population, employment, unemployment and underemployment"
- National capacity building workshops on key steps in developing a national labour market information system

- Provide support with the implementation of 19th ICLS resolution I to countries, based on standardized tools together with a good communication and dissemination strategy
- Support the measurement and reporting of SDGs decent work-related indicators
- Strengthening with the use of a comprehensive LMIS for monitoring the SDGs and AU agenda, including improvement of reporting from administrative records
