# International Labour Organization Volunteer work - current

- Paragraph 38 covers exclusions from volunteer work and subparagraph 38 (c) states the following exclusion:
  - "work for others performed during the working time associated with employment, or during paid time off from an employee job granted by the employer."
  - Possible to interpret that this also excludes volunteer work done during paid leave (e.g. vacation)
  - Not the spirit of the 19<sup>th</sup> ICLS

#### **Proposal**

- Align English and French wording with the Spanish wording by adding:

# International Labour Organization Volunteer work - why

- Current formulation in English has been found ambiguous
- Spanish formulation more precise and less ambiguous

# International Labour Own-use provision of services — current activity clusters

- Four separate activity clusters are listed under own use provision of services - 19th ICLS Resolution I, paragraph 22c:
- i. household accounting and management, purchasing and/or transporting goods
- ii. preparing and/or serving meals, household waste disposal and recycling
- iii. cleaning, decorating, and maintaining one's own dwelling or premises, durables and other goods, and gardening
- iv. childcare and instruction, transporting and caring for elderly, dependent or other household members and domestic animals or pets, etc.



# International Labour Organization Own-use provision of services — ICATUS-16

- ICATUS-16 adopted by UNSC in 2017
- Two inconsistencies v 19th ICLS resolution

#### First inconsistency

- In ICATUS-16 Major division 4 covers "unpaid caregiving services for household and family members".
- Caregiving to pets is included in Major division 3

   "unpaid domestic services for household and family members"
- Therefore activity cluster (iv) from the 19th ICLS is spread across two major divisions

# International Labour Organization Own-use provision of services — ICATUS-16

#### **Second inconsistency**

- ICLS Resolution "household waste disposal and recycling" included with "preparing and/or serving meals" under activity cluster ii.
- ICATUS-16 classifies "recycling and disposal of garbage" under division 32 "Cleaning and maintaining of own dwelling and surroundings ".
- ICATUS-16 classifies "Food and meals management and preparation" under division 31
- Activities under cluster (ii) of ICLS resolution split across 2 ICATUS divisions

# International Labour Organization Own-use provision of services — ICATUS-16

#### Possible amendment to 19th ICLS

- To promote comparability of indicators when 19<sup>th</sup> ICLS and ICATUS are applied
- 1. Move own use provision of service work related to "domestic animals or pets" from the activity cluster (iv) to activity cluster (iii)
- 2. Move own use provision of service work related to "household waste disposal and recycling" from activity cluster (ii) to activity cluster (iii)



# Own-use provision of services 1 hour threshold





## International Labour Own-use provision of services — 1 hour threshold - current

- Reference periods (paragraph 19c)
- Own-use provision of services "one or more 24-hour days within a seven-day or one-week period"
- Own-use production of goods "four weeks or one calendar month"
- Paragraph 21 "the form of work must be engaged in for a cumulative total of at least one hour during the relevant, short reference period"
- Para 22 "any activity" refers to work performed in the various activities under paragraph 22(b) ["production of goods"] and (c) ["provision of services"] for a cumulative total of at least one hour".
- Para 22 suggests we should count one hour of both types of activity combined
- However, reference periods are different making interpretation difficult



### International Labour Overlage Description of Services — 1 hour threshold - current

- Alternative interpretation one hour in either form of work counts as participation – i.e. at least one hour in a 24 hour period
- Implication any activity not covering 1 hour in a 24 hour period or any person not doing at least 1 hour of own-use provision of services would not be considered as participating
- Implications of this on data have become clearer in recent testing on ownuse provision of services measurement



# International Labour Organization Own-use provision of services — SDG 5.4.1

- SDG 5.4.1 proportion of time spent on unpaid domestic and care work, by sex, age and location
- SDG 5.4.1 metadata "This indicator measures the average amount of time as a proportion in a day, so that if for a given country it is reported that women aged 15+ spend 10% of their day on unpaid domestic chores while men in the same age group spend 1%, it indicates that women spend 2.4 hours (2 hours and 24 minutes), while men spend 14.4 minutes on it a day, on average."
- ILO estimates also show that in several world regions average time per day spent by men on own-use provision of services is below 60 minutes
- If all activity not accumulating to at least one hour in a 24 hour period was excluded a large part of the activity would be excluded in calculating SDG 5.4.1



# Own-use provision of services – time-use measurement

- Current time-use measurement practice does not exclude activities less than one hour in a 24 hour period (either individually or in aggregate)
  - In fact measurement based on short periods like 15 minute intervals is common to achieve comprehensive coverage
- Shorter reference period of own-use provision of services plus low intensity of activities for some people creates a different context than other forms of work
- Should we remove the 1 hour threshold?
- If retained can be inconsistency between indicators on own-use provision of services from ICLS, other statistics on time-use or SDG 5.4.1
- Additional consideration so far measurement and reporting on own-use provision of services is limited – but expected to accelerate – concerns about breaks in series could be greater in the future



# Own-use provision of services – possible amendments

- Para 21: Possible addition: "With the exception of own use production (services), a person is considered to have engaged in a given form of work when performing such form of work for at least one hour during the relevant, short reference period."
- Para 22 (a): Current formulation:
  - "any activity" refers to work performed in the various activities under paragraph 22(b) (own-use production of goods) and (c) (own-use provision of services) for a cumulative total of at least one hour
- Para 22 (a): Possible new formulation
  - "any activity" refers to work performed in the various activities under paragraph 22(b) (own-use production of goods) and (c) for a cumulative total of at least one hour, or under paragraph (c), regardless of duration



#### 'Otras actividades productivas'

- During discussions of the committee the wording of 'otras actividades productivas' has been highlighted as a problem
- This relates to 'other work activities' in the forms of work framework
- Committee has proposed to amend the term to 'otras actividades laborales' considered clearer in spanish
- Relevant to the informality discussions
- Appears in para 7(e), para 8, para 10, diagram 1 (forms of work framework), para 17f

# International Labour Organization Points for ICLS

- Possible amendment 1: Volunteer work
- Possible amendment 2: Own-use provision of services to ICATUS-16 alignment
- Possible amendment 3: Own-use provision of services 1 hour threshold
