## ILO's work on YE indicators

- Development of methodologies for employment targets and indicators of global frameworks (e.g. WPAY, MDGs, SDGs and G20)
- System and global database to monitor Key Indicators of the Labour Market (KILM)
- Targets and indicators for national employment policies and youth employment strategies at country level
- A methodology to monitor performance and implementation of youth employment interventions
- A global repository for systematic review and dissemination of findings of youth employment evaluations

# ILO's performance monitoring on YE (1)

## RESULT-BASED MANAGEMENT SYSTEM

Performance measurement

Strategic planning

Formulating objectives;

Identifying indicators;

Setting targets;

Monitoring results;

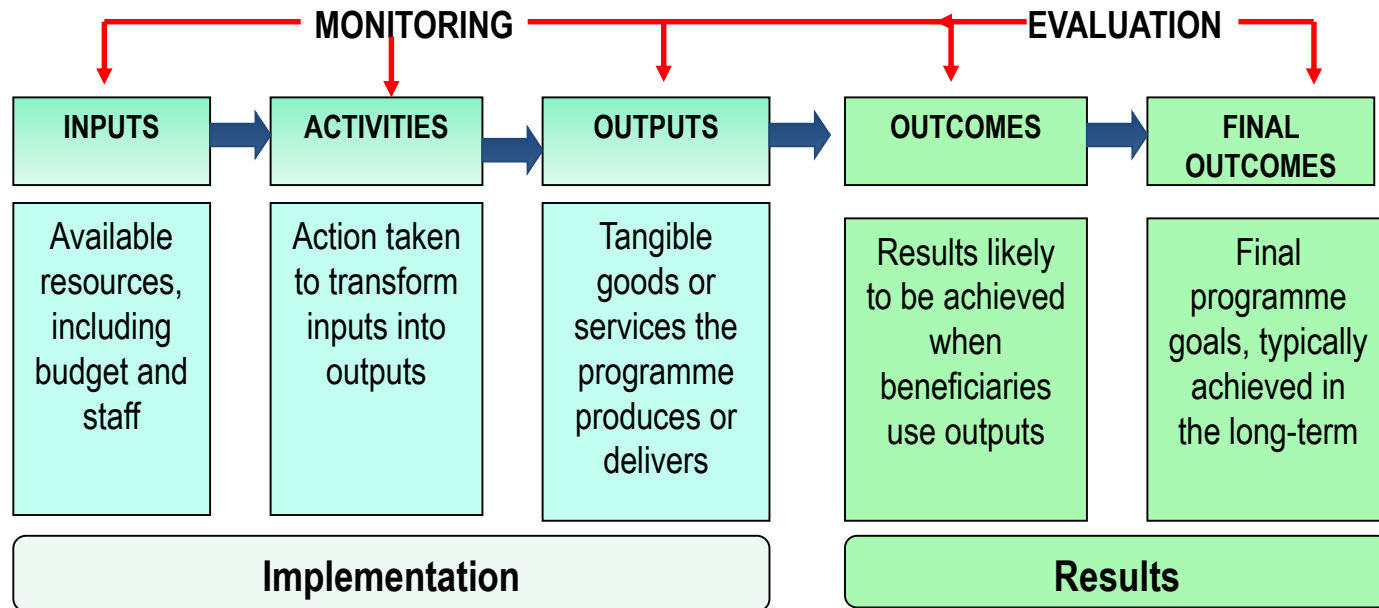
Using performance information to review design/implementation;

Evaluating results;

Integrating lessons from evaluation.

## ILO's performance monitoring on YE (2)

- Input-output relationship in the result chain framework.
- Document programme implementation over time and explain differences across programmes and target groups.
- Information on individual participants (e.g. sex, age group, educational attainment, etc.) allows assessing compliance with targeting criteria.



## Enhancing monitoring capabilities in the context of the YG

- Provide (common) ground rules to multiple implementing partners on the need for monitoring performance and assessing impact
- Help build commitment to and coordinate on pooling of consistent information on implementation of YG
- Discuss and exchange of information on implementation across different partners
- Give tools for monitoring implementation, including to less-experienced partners
- Explain rationale and methodologies for impact evaluation

## Enhancing monitoring capabilities (1)

**Review**



Analysis of YG, existing monitoring system and/or plans

**Training needs analysis  
(TNA)**



Identification of profiles/experience and staff learning needs

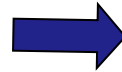
**Design of learning programme**



Development of modules with real case studies, good practice, hand-outs.

## Enhancing monitoring capabilities (2)

**Programme delivery**



Modules based on content of YG and participants are required to provide inputs (e.g. through groupwork, presentations)

**Development of PMS**



PMS developed during the workshop is finalized by team with expert advice

**Support for the development of customized package**

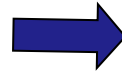


A package with a set of training modules is developed to support rollout of programme to decentralized structure



# Learning package to support national guarantee schemes (1)

**M1 - Youth guarantee schemes in the EU**



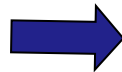
Reviews main features of the YGs with examples of measures/case studies from other countries

**M2 - Key features of national YG schemes**



Analyzes main priorities/measures and helps cluster them by typology

**M3 - M&E Principles**



Provides main principles and rationale for conducting monitoring and evaluation exercises

## Learning package to support national guarantee schemes (2)

### **M4 - Indicators Framework**



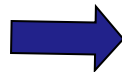
Benchmarks the different sets of indicators against the measures implemented in the country through the development of monitoring plan

### **M5 – M7 Monitoring YG measures**



Reviews existing and/or identifies indicators to monitor results of measures and benchmark with good practice.

### **M8 – M9 Impact evaluation techniques and tools**



Provides evaluation concepts, different techniques and available tools (M8) and advanced training (M9)
