Introduction

SLS was established in 2015 through the optimization and merger of the functions of 3 institutions: the State Service for Mining Supervision and Industrial Safety, the State labour Inspectorate and the partially the State Sanitary and Epidemiological Service.

The range of functions of the SLS is wide. There was no purposeful explanatory communication to the wide audience, and this creates certain barriers for the successful performance of its functions.

The management of SLS plans to develop a communication strategy and to conduct constant active communication activities. It is expected to increase the level of visibility of SLS and understanding of its functions, the formation of the image of the service as one that contributes to improvement of working conditions in Ukraine.



The role and purpose of situational analysis


- Situational analysis is the basis for developing an organization's communication strategy
- The ultimate goal of this situational analysis is to formulate the communication goals and objectives of the SLS and to become a source of information for further strategy and planning



Steps to prepare an effective communication strategy and plan

Top functions of the SLS, which are in the focus of situational analysis



Labour inspection:

- informs and advises employers on the requirements of labour legislation, namely on labour relations, wages, safety and health at work and more
- informs and advises employees on their labour and social rights, labour relations, wages, safety and health at work, etc.
- monitors employers' compliance with labour and OSH legislation
- monitors compliance with the legislation on employment and employment of persons with disabilities
- finds gaps in national labour legislation and propose amendments to the legislation

Market surveillance:

- checks if various types of non-food products sold on the market of Ukraine meet the requirements for occupational safety, health and safety to the life of citizens
 - for example, personal protective equipment, elevators, cable cars, etc.




Number of publications mentioning the SLS in the media* compared to other government agencies

• The SLS is not a generator of peak publications on the topic in 2020: they were generated by O. Honcharuk, the Ministry of Economic Development, Mykhailo Volynets (Confederation of Free Trade Unions) and the National Police



The info field is not controlled by the owner of the topic: neutral publications prevail, and the negative is not balanced by the positive



- The advantages of TV and radio as potential channels for "victories" have not been used



The role of the SLS in publications

The mediafield is formed without the participation of the SLS: in most of publications the SLS is mentioned in an episodic role

- TOP news, where the SLS plays a leading role is negative: Head of the SLS Sazhienko and Minister Petrashko organize corruption schemes in the SLS
- TOP news, where the SLS plays a secondary role is neutral: <u>In Kyiv, companies will close for quarantine if a worker has</u> <u>confirmed COVID-19</u> positive status
- TOP news, where the SLS plays an episodic role is negative: <u>Prosecutor General Iryna Venediktova assesses</u> <u>the first month of work of the new regional prosecutor's</u> <u>offices</u>



The "main" role is assigned to the object under study if it is the central (the only participant) of the action described in the text or is one of the very active participants of the action.

The "secondary" role is assigned to the object under study if it is an indirect participant of the action described in the text.


The "episodic" role is assigned to the object under study, if its appearance is one-time and insignificant, and may not correspond to the general context of hit.

Main topics with the SLS in the info field 1

- Occupational safety and health and labour rights compliance with labour legislation at enterprises, informing about the number of violations and the number of victims. Discussion on the new draft law "On Labour"
- 2. Work during quarantine inspections of enterprises for compliance with preventive measures and working conditions during quarantine; notice of compensation to health workers
- 3. Supervisory activities planning/conducting inspections at enterprises, investigation of accidents at work, relevant regulations
- 4. De-shadowing of employment information on measures of the SLS against undeclared work, inspections of enterprises
- 5. State Mining Supervision information on working conditions in the mining sector, detection of violations

Main topics with the SLS in the info field 2

Resource for increasing positive mentions in the media

Potential topics for strengthening the role of the SLS in publications and filling the info field with positive tonality:

- 1. Occupational safety and health and labour rights the SLS launches a hotline for physicians infected with COVID-19
- 2. Work during quarantine <u>Kyiv companies will close for quarantine if a worker has COVID-19</u> positive status
- 3. **De-shadowing of employment -** <u>Ukraine will strengthen control over compliance</u> <u>with labour</u> legislation
- 4. Labour market Honcharuk wants to create a million jobs in 5 years
- 5. Personnel policy The Cabinet of Ministers appoints a new head of the SLS
- 6. Employment of people with disabilities -reduced working day of a person with disability from the group established and paid according to the MSEC certificate? (print media)



What formats are missing in the info field


- Positive news with a focus on the result, not the process
- Stories

 - positive cases from business owners regarding healthy competition

 - with the heads of the SLS
- **Explainers**
 - clarification of labour legislation in simple language
 - explanation of the advantages of the electronic service of the SLS



Distribution of publications mentioning the SLS in the media* by region

- Almost half of the content is generated by regional media, but they provide little coverage
- The large gap in the activity of different regions demonstrates that not all regions use the potential of newsworthy events equally effectively
 - the activity of Kharkiv region is more than 5 times higher than the activity of Chernivtsi or Chernihiv region

Number of publications by region



Status of mass media actively mentioning the SLS

Publications mentioning the SLS are concentrated in the media with a small coverage:

- only 6% of media from the TOP-100 list are among those that mention the SLS
- the largest share 49% of publications in regional media, which provide a small audience coverage even in the regions



Conclusions based on the results of media monitoring

- 1. The total number of mentions of the SLS in the media in 2020 32,976 is small compared to other government agencies
- 2. The most common topics are "Occupational safety and health and labour rights" and "Work during quarantine"
- 3. The mediafield is not formed and not controlled by the SLS:
 - 87% of mentions have a neutral tonality
 - the negative is not balanced by the positive
 - in 68% of mentions the SLS has an episodic role
 - SLS initiated only 17% of mentions among the TOP-100 and offline news
 - SLS is not a generator of peak messages
- 4. Almost half of the content is generated by regional media, but they give little coverage
- 5. Opportunities for cooperation with the media and speakers are not fully used:
 - TV and radio potential is not used to cover the "victories"
 - only 6% of the media from the TOP-100 list are involved
 - few speakers from the SLS



Publications comparing to other state agencies

- the total number of publications mentioning the SLS for 9 months 6,145 (683 per month)
- compared to the presence in the media, the SLS looks more active than the SES in social networks, but lags far behind the Ministry of Economy and the State Tax Service



Dynamics of the volume of mentions in social networks









Regional distribution of sources


A large share of content (38%)

Conclusions based on social networks monitoring

- 1. Among social networks, Facebook is the main source of information almost 62%
- 2. Information from official sources prevails
- 3. Representation of the SLS topic is low compared to the topics of other state agencies
- 4. For the most part, the tonality of the mentions is neutral
- 5. Only half (55%) of content on social networks is published in Ukrainian
- 6. A large share of content (38%) is created in the regions
- 7. Content on the topic of SLS is well distributed on the pages of relevant government agencies, professional publications, law firms and large manufacturing enterprises

Such representation of the topic on social networks indicates that the audience does not understand the essence of the SLS activities



Mentions in comparison with other government agencies

- the total number of publications mentioning the SLS for 9 months 9,530 (1,058 per month)
- SLS and SES are equally active but lag far behind the Ministry of Economy and the State Tax Service







Mentions by language used

The predominance of Ukrainianlanguage web resources is due to the requirements of the legislation for the use of the state language by State authorities





Regional distribution of sources

- More than 93% of web resources that do not belong to the category of media and publish content on the subject of SLS are regional
- All-Ukrainian resources make up only 7%
- An important part of the content of all-Ukrainian resources is the duplication of news / events / descriptions of results published on regional sites



Conclusions of the web resources analysis

- 1. The topic of SLS is better represented on the web-sites of state agencies, NGOs and large enterprises, than on social networks
- 2. The number of mentions remains low compared to that of other government agencies
- 3. The tonality is mainly neutral
- 4. Almost all mentions are published in Ukrainian, as official sources predominate in the field
- 5. Regional sites are a source of news for Kyiv






The volume of search queries

- Seasonality of demand and growth of interest in the topic are absent
- The largest volume of search queries was carried out in September 2019 February 2020, which is due to amendments to the Law "On labour protection"



The volume of searches of the SLS in comparison with other state bodies

- the level of queries on the topics of the SLS looks good against the background of the Ministry of Economy and the Tax Service due to inquiries regarding the updated Law "On labour protection"
- the surge in requests for SES in 2020 is associated with an exacerbation of unemployment and job losses due to the pandemic




The most popular search queries

Inspection / labour protection search results in Russian

- with regard to labour inspection, the search results in Russian differ significantly from those in Ukrainian
- Google offers the ILO and the Labour Service of the Russian Federation
- the Google search results on OSH offer not only Ukrainian sources, but also Russian ones, which contain information about the Russian Federation and its legislation
- Most of the search results are information and education materials or sites of NGOs that provide services in the OSH field



Conclusions regarding Google search results

- Ukrainian- and Russian-language Google search queries on SLS and labour inspection refer to the official resources of SLS
- 2. The largest volume of search queries was carried out in September 2019 February 2020, which is due to adoption of amendments to the Law "On labour protection"
- 3. The websites of the SLS and its contacts are usually searched in Ukrainian
- 4. Among Russian-language queries, explanatory information on the OSH and the Labour Inspection were most popular
- 5. For queries in Russian about health, safety and hygiene at work, Google mostly offers educational materials from Russian resources
- 6. There is neither seasonality of demand, nor growth of interest in the topic



General conclusions about the media field

- 1. The audience is rarely interested in the SLS, because it does not understand the importance of its activities for themselves, in contrast to, for example, the activities of the State Employment Service
- 2. The info field is not formed and is not controlled by the SLS
- 3. Top management is little involved in promoting the SLS
- 4. The work of the Labour Department of the SLS with the media makes a significant contribution to the info field in terms of the number of publications, but has a small coverage
- 5. High demand of the audience for content in Russian
- 6. The lack of regular monitoring of the info field does not provide an understanding of the effectiveness of communication efforts



Recommendations on the work with the informational field

- Explanatory work on what the SLS functions are
- 2. Active work with the media field:
 - filling the info field with "victories"
 - news should focus on the result, not the process
 - to prevent negative coverage
 - filling the info field with explanatory materials
 - promoting SLS speakers
 - strengthening work with the TOP-100 media
 - continuing to work actively with regional media
 - improving the quality of content, switching to "human language"
- 3. Allocation of resources to work with search queries: the queries in Russian should lead to Ukrainian content, not Russian one
- Allocation of resources for regular monitoring of the info field to monitor the effectiveness of communication efforts

It is necessary to strengthen resources of the SLS for communication: advanced training of existing staff, involvement of qualified specialists, allocation of funds for communication
